<p>NARRATIVE: (PC and Elements to the Charged Crimes. Details on a Supplementary Report) Narrative not required if already covered in an Incident Report for Crime Against Person.</p> <p>On Saturday, July 25, 2020 at 2200 hours Reporting Officer (R/O) KRUSE #2074 was directed to stage at 29th and Farnam Street regarding a large protest/march which had been blocking entire streets disrupting vehicle traffic for a lengthy period of time. The protestors had been verbally informed multiple times that they were engaging in an unlawful assembly and that they were under arrest for that crime. All parties involved were directed to sit on the ground as they were under arrest. R/O gave Matthew JOHNSON (9-19-1988), who was now standing on the southside of the bridge located at 29th and Farnam Street. JOHNSON refused to comply with a lawful order and R/O attempted to remove JOHNSON from the crowd and place him under arrest at which time JOHNSON pulled away from R/O multiple times in an attempt to hinder his arrest. JOHNSON was eventually taken into custody. JOHNSON was booked into Douglas County Corrections for unlawful assembly, resisting arrest, and obstructing.</p> <p>Sgt.
