R/Os HIRZ #2216 and SEIKER #2218 were dispatched to 5324 N 35th St to investigate a domestic disturbance. Upon arrival, R/Os made contact with victim, who stated that her husband, LOPEZ-CARDONA, Eduardo (DOB 10/ 13/89), threatened her and broke the window to the side door to chase after her. R/Os determined through the investigation that probable cause existed for the arrest of LOPEZ-CARDONA. R/Os approached LOPEZ-CARDONA and escorted him away from other parties to place him under arrest. R/Os attempted to place LOPEZ-CARDONA in custody, but he began to actively resist immediately. R/O HIRZ observed that LOPEZ-CARDONA had a folding pocket knife in his front right pocket, and he made apparent motions to grab the knife from his pocket. R/O HIRZ then removed the knife from his pocket. LOPEZ-CARDONA was still actively fighting with R/Os, and R/O HIRZ had no choice but to discard the knife by throwing it away from the fight. The knife landed in the street underneath a parked vehicle. LOPEZ-CARDONA was finally subdued and placed into a cruiser, but R/O HIRZ was not able to find the pocket knife thrown. LOPEZ-CARDONA was uncooperative with officers after that point, so R/O was not able to determine the make/model or cost of the knife. LOPEZ-CARDONA was booked into DCC for 3rd Degree Domestic Assault, DV Criminal Mischief, and Resisting Arrest. 3C40 Sgt PEATROWSKY #1841 and 3C1 Lt WOOLMAN #1517 were on scene. Narrative: On SAT 25 JUL 2020 at 1742 hours R/Os SEIKER 2218 and HIRZ 2216 were dispatched to a domestic disturbance. Upon arrival R/Os made contact with GARRIDO, Sandra (9/24/1973) and GARRIDO, Melanie (8/31/2008). Investigation revealed LOPEZ CARDONA, Eduardo (10/13/1989) threatened to slap GARRIDO, Sandra following a verbal argument in the back yard. GARRIDO, Sandra and GARRIDO, Melanie stated they ran inside the house and locked the door behind them. Both GARRIDO, Sandra and GARRIDO, Melanie hid inside a bathroom out of fear for their safety as they heard the window to the door smash. As R/Os were attempting to arrest LOPEZ CARDONA he pulled away from R/Os and physically resisted efforts to be placed in handcuffs by keeping his hands clasped in front of him. After a brief struggle R/Os were able to take LOPEZ CARDONA into custody. LOPEZ CARDONA was booked into DCC for DV Assault 3rd Degree, Criminal Mischief, and Resisting Arrest.
