ON Saturday 25 July 2020 at approximately 1930 hours, Reporting Officer BRAZIER #2240 along with other officers were watching over a protest which was going on in the area of Farnam Street and Turner Blvd on the southeast corner of Turner Park. The protest was followed and information was gathered that the protesters were going to become mobile and head to the Civic Center. At approximately 2045 hours the protesters (around 200) began to walk eastbound on Farnam in the street against traffic and blocking the flow of traffic. At this time the protest was declared Unlawful Assembly As the protesters made their way eastbound on Farnam officers followed to block off traffic off their path. The crowd continued eastbound into the Old Market (south 13th and Farnam) before they turned south on 13th to Howard, East on Howard to 11th, North on 11th to Harney, West on Harney to 19th, North on 19th back to Farnam and then westbound on Farnam. As the crowd walked this route numerous announcements were made that this was an unlawful assembly and that the people were subject to arrest.

As the crowd made their way towards south 29th and Farnam they were stopped and again advised that this was an unlawful assembly and that they were all under arrest. At this time R/O and other officers were giving orders for the people within the crowd to sit down. At this time one of the people in the crowd, identified as VONDRASEK Mark, appeared to set/load his bicycle pedal in a manner which appeared like VONDRASEK was going to try and ride through the police. A moment later VONDRASEK tried to ride his bike towards another officer but was stopped and pepperballs were deployed and VONDRASEK tried to get away from officers as they tried to arrest him. VONDRASEK was taken into custody after a brief struggle.

VONDRASEK was booked into Douglas County Corrections for Obstructing Traffic, Unlawful Assembly, Resisting Arrest.
