21 **COUNT ONE**

22 On or about March 19, 2021, in the County of Placer, the
23 crime of ASSAULT WITH PERSONAL USE OF DEADLY WEAPON, in violation of
24 PENAL CODE SECTION 245(a)(1), a Felony, was committed by DANIEL
25 LOZA, who did willfully, unlawfully and personally commit an assault
26 upon A.V. with a deadly and dangerous weapon, a vehicle.

COUNT TWO

On or about and between March 1, 2021 and March 18, 2021, in the County of Placer, the crime of CRIMINAL THREATS, in violation of PENAL CODE SECTION 422(a), a Felony, was committed by DANIEL LOZA, who did willfully and unlawfully threaten to commit a crime which would result in death and great bodily injury to A.V., with the specific intent that the statement be taken as a threat. It is further alleged that the threatened crime, on its face and under the circumstances in which it was made, was so unequivocal, unconditional, immediate and specific as to convey to the victim a gravity of purpose and an immediate prospect of execution. It is further alleged that the said victim was reasonably in sustained fear of his safety and the safety of his immediate family.

"NOTICE: The above offense is a serious felony within the meaning of Penal Code section 1192.7(c)(38)."

SPEC ALLEG-USE OF FIREARM

It is further alleged that in the commission and attempted commission of the above offense, the said defendant(s), personally used a firearm(s), within the meaning of Penal Code sections 1203.06(a)(1) and 12022.5(a)(1) also causing the above offense to become a serious felony pursuant to Penal Code section 1192.7(c)(8)

1 and a violent felony within the meaning of Penal Code section
2 667.5(c)(8).

4 COUNT THREE

5 On or about March 19, 2021, in the County of Placer, the
6 crime of RESIST, OBSTRUCT, DELAY OF PEACE OFFICER OR EMT, in
7 violation of Penal Code section 148(a)(1), a Misdemeanor, was
8 committed by DANIEL LOZA, who did willfully and unlawfully resist,
9 delay and obstruct Officer Fox and/or other Roseville Police
10 Officers, Public Officers attempting to and discharging the duty of
11 their office and employment.

16 On or about and between March 1, 2021 and March 19, 2021,
17 in the County of Placer, the crime of HUMAN TRAFFICKING A MINOR, in
18 violation of Penal Code section 236.1(c)(1), a Felony, was committed
19 by DANIEL LOZA, who did unlawfully cause, induce, persuade, and
20 attempt to cause, induce, and persuade, Jane Doe (DOB 7/5/2006), who
21 is a minor, to engage in a commercial sex act with the intent to
22 effect or maintain a violation of Penal Code section 266, 266h,
23 266i, 266j, 267, 311.11, 311.2, 311.3, 311.4, 311.5, 311.6, or 518.


