1. Overview

SDSU Georgia Public Private Partnership Fund (PPPF) was established to generate resources to make internationally accredited STEM programs affordable for successful, socially disadvantaged or other vulnerable students in the country. The official launching event of the Public Private Partnership fund (PPPF) took place on November 16, 2016. The event was attended by leading Georgian public and private organizations. Several business partners awarded SDSU Georgia students with scholarships during the event.

Prior to the launching event, negotiations were held with one of the leading Georgian banks, TBC bank, to set up the PPPF account in partnership with TBC's charity foundation. SDSU in Georgia has adopted the Campanile Foundation's gift and donation agreement templates in processing all scholarship donations to date, and each agreement has been approved by the Campanile Foundation (TCF) and SDSU's local legal consultant prior to final signature. Donations can be transferred directly to Campanile Foundation or through TBC Bank. The following payment process was agreed for donations:

- The donor is matched with SDSU-Georgia student(s)/scholar(s)
- > Donor agreement is negotiated and signed with the donor and the intermediary Foundation (or with the Foundation directly)
- > Grant agreement is signed with donor, student(s) and the intermediary Foundation (or with the Foundation in case the Foundation stands as a donator)
- > SDSU Georgia submits the payment request for tuition according the agreed schedule
- > Donor wires scholarship funds to TCF, Tree of Life Foundation or TBC Fund per payment request
- > SDSU Georgia submits request to the relevant intermediary Foundation

2. Main Communication Channels

A special strategy was developed to raise the awareness of the target audience on PPPF, establish good working relations with leading public and private organizations, and attract donations.

The main communication channels and tools used for PPPF included:

3. Main Events and Activities Implemented

SDSU Georgia impalements numerous activities and events to identify new donors and partnership opportunities as well as keep existing partners informed and committed. Prior to the official Launching event of the PPPF, targeted one-to-one meetings with the CEOs of leading business organizations in Georgia were held. Special Invitation for Partnership letter and PPPF one-pagers were prepared and shared/delivered with 150 public and private sector companies. In addition several special high level events and presentations were organized including dinner at U.S. Ambassador's residence and presentation at American Chamber of Commerce (AmCham).

The following activities were implemented during the reporting period:

3.1 One-to-one meetings

One-to-one meetings are ongoing with the CEO's of top public and private organizations in Georgia.

- August 16, 2017 SDSU Georgia PPPF existing and prospective donors were invited to a special Dinner with the former director of the Metropolitan Museum of Art in New York (1977 to 2008) Philippe de Montebello; Event was hosted by the U.S. Ambassador to Georgia.
- January 29, 2018 PPPF donors were invited to attend the official topping out ceremony of the new campus at Ilia State University
- February 8, 2018 Dr. Bill Tong's Lecture and Luncheon for PPPF Donors

3.3 MoUs w/public and private partners

MoUs were signed with leading public and private partners including Ministry of Finance, leading Georgian Energy companies, and other public or private organizations to support student employment, research, internship as well as scholarship opportunities.

SDSU Georgia continues negotiations with Public and Private sector on future cooperation and MoU opportunities. MoU with Anaklia Development Consortium (ADC) was signed in June 2018.

3.4 Annual Job and Internship Fair

During the reporting period two internship and job fairs were organized in Tbilisi; 45 companies participated in the first internship fair in 2016 and 56 companies participated in internship fair in 2017. More than 40% of students (freshmen and sophomore) participating in the internship fair were able to find part time jobs or internships in these companies. Next internship fair is planned for June 7, 2018.

It should be noted that SDSU Georgia students undergo a special CV writing and job interviewing techniques training before the annual internship fair so that they are prepared for their first job and internship searching opportunity. In 2018 SDSU Georgia plans to establish a special career center to prepare seniors for their future career and equip them with all necessary skills.

3.6 Publicity and Marketing Materials

- "Special Case for Support" document was developed for meetings with donors.
- Special information package was developed for meetings which included (1) a one pager on PPPF, (2) one pager on how to support the student with detailed information on scholarship types, timeline, financial info, etc.; (3) successful student profiles; and other materials as and when required.
- Thank you letters are sent by SDSU Georgia Dean to all PPPF donors after the donor agreement is signed.
- Special, creative gift packages are delivered to PPPF donors and partners for Christmas. The gift
 packages include special annual publication on student success stories funded by donors: Spotlight
 on Student Success.

3.7 Targeted media coverage

News and updates on PPPF events as well as SDSU Georgia student success stories were covered in media outlets like: Forbes, Investor.ge, Georgia Today, Business morning, etc.

3.8 Working group meetings (MCC, MCA-G, SDSU-G)

To coordinate the joint fundraising efforts, working group meetings were organized twice a month. During the meetings MCC, MCA Georgia and SDSU Georgia representatives updated each other on progress as well as discussed future plans and activities.

3.9 Website and Facebook

"Give to SDSU Georgia" page was included on SDSU G website. The PPPF fundraising campaign page on SDSU G website is in progress and is planned to be ready in June 2018.

All news on PPPF events as well as student success stories including on student internships and jobs are regularly posted on SDSU Georgia website as well as the SDSU Georgia Facebook page.
