Evidence Supplemental Narrative:

Due to technical difficulties on Alliance, Sergeant Szopinski was unable to book the CD as evidence. Sergeant Szopinski kept the CD in his locker until he gave the CD to me.

I booked the CD into evidence locker #1 at the Lake Merritt Evidence Room.
