Summary:

The following summary is based on a review of records, documents, incident reports and taped interviews.

OVERVIEW:

On May 26, 2006, during the 0700-1500 Watch at CJ#1, Deputy Scott Neu #1823 was assigned to Post 10 with Deputy Juan Guitron #1894 and Deputy Robert Cooper #777. Sometime during that watch, Inmate was loud and disruptive. Deputy Scott Neu instructed Deputy Juan Guitron to pop open Cell J-01. Deputy Neu allegedly entered cell and without reason punched several times on the left side of his body. alleges that Deputy Neu kneed him on the left side fracturing his ribs. Inmate related that a day or two after the incident, Deputy Neu attempted to apologize and offered a cookie. Inmate had his ribs X-rayed on 05/30/06, X-ray confirmed fracture to left 9th lateral rib.

BACKGROUND

According to Facility and Medical records, Inmate is a documented disruptive inmate. Inmate has had several Safety Cell Placements for suicidal ideation. has been charged for "Gassing" while in the custody of the SFSD. has an extensive history of harassing female staff members.

Captain Butler Memo dated 06/27/06 to Chief Arata paraphrased:

Captain Butler received a grievance from Inmate that was sent to Captain Butler by Sergeant Daggs (SFGH). alleges that Deputy Neu entered his cell. Neu proceeded to punch, kick, and knee Inmate alleged that he fractured his ribs. Captain Butler confirmed with JMS that did indeed have fractured ribs. did not indicate the time of incident, however he first complained about the ribs on 05/27/06 during a safety cell placement. Captain Butler was not aware of any situations where they had to struggle with Inmate causing this injury. Sergeant Daggs told Captain Butler that there was one event where had to be placed in four point restraints, but it was uneventful. Deputy Neu was assigned to Post Ten on 05/26/2006. Several inmates with (PSY) codes have made allegations against Neu. Captain Butler wrote that Neu had entered her office and asked her if there was anything that he was doing that she wanted to talk to him about. Butler found that strange. The allegations are made by psychiatric inmates, however an inmate has broken ribs and Neu is the only Deputy that was mentioned. Please review and advise.

Taped interview #2 with Paraphrased: Inmate was informed by this investigator that he needed to be interviewed a second time to clarify a couple of items. This investigator read the photo lineup admonishment to and had him sign it. was given a photo lineup of the deputies that were assigned to Post 10 on 05/26/2006. was able to identify every deputy in the photo lineup except Deputy identified Deputy Guitron as the deputy that opened the gate to Cabuloy. his cell. When asked, recalled that Guitron opened the gate from outside. recalled that Guitron did not enter his cell. When asked, When asked, said his cell was right next to the main door to the tank. said the incident happened in his cell not the common area

Taped interview with **Deputy Juan Guitron # 1894**Synopsis: Deputy Guitron was assigned to the Swine

Synopsis: Deputy Guitron was assigned to the Swing Watch on the day of the incident. He recalled that he was assigned to Post Ten with Deputy Neu, Deputy Cooper, and Deputy Wolske. When asked, Deputy Guitron related that he did not


recall anything out of the ordinary that day. When asked about Inmate Guitron recalled that he was loud that day. When asked a second time if he recalled anything specific about Inmate that day, Guitron recalled that Deputy Neu told him to open J-Tank. Guitron related that he was pre-occupied with pill call and the jail noise, so he was not able to look into Guitron said Neu told him to open J-Tank. Guitron complied. Neu then told Guitron to open cell. Guitron complied. Guitron assumed that Neu was going to take to Toper. Guitron said it became quiet. Guitron related that he heard Neu say, "Turn around and cuff-up?" told Neu to "Fuck Off." At this time, Guitron was reminded that he had recently graduated from the academy and core class. He was reminded that his JTO instructor more than likely instructed him to keep an eye on his partner when entering an ADSEG cell. When asked a second time, Guitron related that Neu entered Guitron heard "muffling sounds." Guitron then heard "thuds." Guitron was not able to describe what the "thuds" were. Guitron said he did see knees with his chest pressed up against his bunk. Guitron said Deputy Neu was Guitron said he saw Neu push into his bunk. Neu then said over something like, "Respect the men in the black!" Neu exited and then he slammed the cell door. never went to Toper. When asked, Guitron related that Deputy Neu always appeared "Pissed Off." When asked, Guitron said Neu's demeanor when he exited the tank was the same as always (referring to being "pissed off."). On that same day, Deputy Guitron said he made a round in J-Tank with Deputy Cooper. told Guitron and Cooper, "My ribs hurt," "I think they are broken." Cooper told that he was alright. When asked, Guitron said Deputy Neu never called a supervisor. Deputy Guitron never entered cell. The next day, Guitron spoke to Guitron related that said his ribs were still hurting. said, "Neu broke my ribs." Guitron recalled that this conversation took place when was in the safety cell. Guitron recalled that wrote in feces, "Neu the poo" on the Safety Cell Wall. When asked. did not attack Neu. When asked. was compliant. When asked Guitron believed the "thud" was when fell to his was never handcuffed according to Guitron. Guitron was asked if he thought Neu's actions were inappropriate. Guitrion said, "yes," "I was trained differently."

<u>02/12/2007 @ 1540 Hrs.</u> Taped interview #2 with <u>Deputy Juan Guitron #1894</u>
ADA Diane Knoles present. Synopsis: Deputy Guitron's account of the incident was consistent to the interview given on 07/13/06, except: 1) After Guitron heard thuds in Cell #1, Guitron looked into the cell and heard say, "Fucken Neu, I think you broke my ribs."

When Maaref made that statement, Neu was on top of him. 2) Guitron did not recall Neu telling Maaref to take down ties or artwork. 3) After the first interview, Neu approached Deputy Guitron and asked him if he had spoken to IA regarding the incident with Maaref. Guitron said Neu was surprised that Guitron did not tell him. Neu said, "Dude weren't you going to tell me." Guitron said Neu apologized for putting him in this situation.

02/16/2007 @ 1518 Hrs. Taped interview #3 with Deputy Juan Guitron #1894 ADA Diane Knoles present Synopsis: When asked, Guitron did not recall observing Neu going into Maaref cell to retrieve contraband. When asked, Guitron did not recall Neu mentioning contraband. When asked, Guitron did not recall getting an explanation on why Maaref did not go to Toper or the Safety Cell. When asked, Guitron was under the impression that Neu was going to cuff Marref at the gate, but he did not. Instead, Neu told Guitron to open the gate. When asked, Guitron said he was distracted for 5 to 10 seconds after he opened the cell for Neu. When asked, Guitron said the reason why he did not look into the cell was not because he did not want to witness what was going on. Guitron related that he spoke to OE3 representative Dave Gossman. When asked, Guitron said he did not tell Neu that ribs were broken. However, Guitron said he assumed that Neu was aware that they were broken because he (Neu) mentioned that Maaref was "Tuned-up" by the midnight crew during a Safety Cell Placement.

Synopsis: recalled the incident regarding Deputy Neu.
He recalled that a disruptive inmate that the inmates called
"Poppy" was being loud that day. recalled that "Poppy"
was housed in the first cell in J-Tank. recalled that there
were words exchanged between Deputy Neu and the inmate.
Deputy Neu ordered the inmate to be quiet several times, but the inmate
continued to be disruptive. recalled that profanity was exchanged on
both sides. recalled that Neu asked another deputy to open J-1. The
deputy opened the door from the Mainline and Neu entered the cell.
recalled that he heard a commotion. said he heard shoes moving
around. related that he could not see anything. related that Neu
was in the inmate's cell for 45 to 60 seconds. When asked, said he did
not hear Neu or any deputy say "Turn around and cuff-up." When Neu exited the
tank, recalled that the inmate was upset because Neu ruined his artwork.
said the inmate told him (that his ribs hurt. told
that Neu kicked him in the ribs. recalled that the inmate saw medical a
day or two after the incident. has not seen the inmate since. When
asked, said there was not a supervisor present when he entered the
inmate's cell. When asked, said the inmate was not on the phone.



recalled that the Deputy that opened the door was paranoid to open the gate. Neu had to tell the Deputy four times to pop open the gate. said he saw Neu walk into the cell. said it was only Neu that entered the cell. said he heard hollering. said he heard Neu kick the inmate at least three times. said he heard grabbing then the Arabic guy went to the floor. described Neu as Caucasian. He recalled that he was heavy set and had recalled that the inmate said, "My ribs!" "My ribs!" a "Hitler" haircut. said he told Neu that he was not supposed to do what he did. Neu said, "You know how we do it!" recalled that Deputy Cooper and possibly Lt. Dorsey gave the Arabic guy three plates of chicken. recalled that Neu lectured the Arabic guy while he assaulted him. recalled that the incident happened after lunch.

08/22/2006 @ 1534 Hrs.

Taped interview w/ related that Inmate told him that

Deputy Neu broke his ribs. related that complained about his ribs in late May 2006. related that Deputy Neu filled an empty milk carton with water from a mop bucket and attempt to give it to who was in a Safety Cell. related that Inmate would only act up when Deputy Neu was working. When asked, said he did not have any animosity toward Deputy Neu. said Neu treated him fair.

09/07/2006 @ 1352 Hrs.

Taped interview with **Deputy Robert Cooper #777**


Paraphrased: Deputy Cooper regarded Deputy Neu as a coworker only. Deputy Cooper did not socialize with him away from work. Cooper related that he called Neu one time, so that Neu could retrieve his bank card from his locker. Cooper said Neu lived by him so it was convenient. Deputy Cooper recalled Inmate was loud and complained a lot. Cooper recalled He related that said he was "roughed up," but Cooper did not know anything specific. that Cooper recalled that complained that his back and sides were hurting. Cooper recalled that mentioned being roughed up at a Safety Cell, not J-Tank. Deputy Cooper did not recall working with Neu at Post 10 on or about 05/26/06. When asked, Cooper said he did not have any conversations with Deputy Neu regarding Cooper did not recall any contact with the presence of Neu and Deputy Guitron. When asked, Cooper said in did not tell him that Neu had done something to him. When asked, Cooper said did not tell him that Sheriff's Personnel had injured him. When asked, Cooper said he recalled that his ribs were hurting that night. Cooper said a nurse came to see at the Safety Cell between 2000 Hrs.-2100 Hrs. Cooper related that was in the Safety cell when he mentioned being "roughed up" and complained about pain to his side and back.

When asked if he told told him that he had broken ribs, Cooper said, "I would never say that." Deputy Cooper did not hear anything about Deputy Neu assaulting Inmate When asked, Cooper said he did not give this inmate any extra food other than what was served.

09/07/2006 @ 1614 Hrs. Taped interview with Sr. Deputy Robert Trevizo #1104 Paraphrased: SD Trevizo characterized Deputy Neu as a co-worker not a friend. SD Trevizo recalled Neu told him that had paperwork on the walls of his cell refused to take the paperwork down. Neu entered the cell as a deputy stood by. advanced toward Neu. Neu extended his hand and pushed against the cell wall. Neu exited the cell. After Neu told Trevizo about his contact with Trevizo instructed Neu to generate a NRV. SD Trevizo related that the NRV presented to him today was the same NRV Deputy Neu handed him on 05/26/06. When asked, SD Trevizo was asked why the NRV narrative by Neu was different than his (Trevizo's) recollection today. Trevizo said he recalled Neu telling him about the threats. When asked why he did not include the violation regarding cell. Trevizo said he did not know why. When asked if he paperwork in heard the actual threats made to Neu, Trevizo said no. Trevizo said he heard other threats, but did not recall what he said specifically. SD Trevizo said he did not observe Neu enter cell. SD Trevizo did not recall seeing Cooper or Guitron. When SD Trevizo adjudicated the NRV, did not complain of any injuries. However, SD Trevizo recalled that made allegations against Neu during a Safety Cell Placement after 05/26/06. said, "Watch out I got broken ribs!" "Neu did it to me." SD Trevizo did not believe at that time because he moved around without discomfort. When asked, SD Trevizo said he did not contact medical. When SD Trevizo was asked if he conducted his own investigation, SD Trevizo said he thought he told Medical but did not remember what they said. When SD Trevizo was told that he said he "did not" tell medical earlier in the interview, SD Trevizo said, "I told Medical." When asked to clarify when he heard the threats from SD Trevizo said it was after Neu approached him (Trevizo) about the incident with SD Trevizo related that Deputy Neu approached him sometime in June. Neu told Trevizo that he expects IA to interview him (Trevizo) because alleged that he (Neu) broke is ribs. SD Trevizo said he went to medical to confirm that broken. SD Trevizo said there were two reports. One report confirmed that his ribs were broken. When asked if the broken ribs were a concern, Trevizo said he did not take it seriously due to past behavior. When asked, SD Trevizo

said he did not instruct Neu to write an incident report.



When asked, Dr. indicated that it is difficult to determine how old a fracture is by reviewing X-rays. When asked, Dr. could not determine if the patient would have experienced excruciating pain. related that everyone has a different tolerance for pain.


Taped interview with **Deputy Scott Neu #1823**

Paraphrased: Neu related that he was on duty at CJ#1 on At approximately 1000 Hrs, Neu discovered 05/26/06. contraband in cell. Neu related that making Origami Dress Ties out of pages from magazines. Neu said he ordered to dispose of the contraband, but did not comply when Neu returned to his cell an hour later. When asked again, refused to turn over the contraband. Neu related that he told Guitron to pop open Cell J-01. Neu ordered to step back as Neu entered cell to confiscate two magazines located on top bunk. then approached Neu with his hands in the air. Neu said he pushed with his right hand. On a scale of 1 to 5, Neu said the force he used was a two. fell to his knees and placed his head on his bunk. Neu related that he took the contraband and vacated Neu later said after he pushed ended up on his knees with his body wedged between the toilet and the wall. When asked, the only contact Neu was when he pushed left shoulder. When asked, made with Neu said did not sustain any injuries. Neu related that SD Trevizo was satisfied with a verbal report of the incident. Neu was not aware that injured until two weeks after the incident. Neu related that SD Trevizo and he spoke to an unknown nurse to confirm that had X-rays done. Neu related did not pose any eminent danger; therefore there was no need to that handcuff him. When asked, Neu said he did not review Field Arrest Card nor did he investigate the reason why he was in ADSEG prior to entering was not combative. When asked, Neu related that SD his cell. Neu said Burris did advise him to handcuff ADSEG inmates, but only if they are removed from their housing area. Neu said he just followed SD Burris as an example. because Burris would enter Inmate's cells to remove contraband. When asked, Neu said Deputy Guitron wouldn't have been in plain view if he was at the "Lockbox." When asked, Neu said he did not call for back up or ask for a supervisor. When asked, Neu said he did not tell "Don't mess with the guys in the black." When asked, Neu said he did not talk to Deputy Guitron regarding the IA Investigation.




Deputy Guitron related that he stood at the control box as Deputy Neu entered cell J-01. Guitron said he did not look into the cell the entire time, but he heard muffling sounds and then thuds. Guitron said he saw Deputy Neu push was kneeling on the ground. Guitron heard Neu say, "Respect the men in the black!" Pg 22-26 of Deputy Guitron's Transcript dated 07/13/06 Before Deputy Neu exited cell, Deputy Guitron heard Inmate say, "Fucking Neu, I think you broke my ribs!" Pg. 17 of Deputy Guitron's Transcript dated 02/12/2007 Prior to 05/26/06, medical records do not mention any injury to his complain of any injury to his ribs. ribs nor did told Deputy Guitron and Deputy Cooper that his ribs hurt ten to fifteen minutes after contact with Deputy Neu on 05/26/06. On May 30, 2006, Inmate X-rays taken at CJ#1. X-rays taken on 05/30/06 show a fracture to the ninth left rib. You failed to seek medical attention for Mr. Allegation #3 injuries. Deputy Neu said that he was not aware that sustained broken ribs until weeks after his contact with which was on 05/26/06. Neu said he told SD Trevizo and they checked with medical. They discovered that was Xrayed but were not aware of any results. Deputy Neu said if hadn't been seen by medical, he was going to make arrangements for him to be examined. 9.6 Departmental Investigations- Unethical Conduct
Deputy Neu informs Sr. Deputy Trevizo that he (Neu) is being investigated because had accused him of breaking his ribs. Neu told Trevizo that since he was the supervisor his name might come up. Sr. Deputy Trevizo and Deputy Neu checked with JMS to see if Maaref Ribs were broken. Trevizo said one report indicated ribs were broken and another report indicated they weren't. Pg 31 & 32 of Sr. Deputy Trevizo's Transcript
Deputy Neu approached Deputy Guitron and asked Guitron why he did not divulge that he was interviewed by Internal Affairs. Deputy Neu asked Guitron what did he tell IA. Guitron said he told IA what he saw. Neu apologized to Guitron for placing him in this situation. Pg 34 and 35 of Deputy Guitron's 02/12/07 Transcript.
9.7 Truthfulness
#1 Neu alleges that he entered Maaref's cell to remove contraband and that was not loud and disruptive
Deputy Neu related in his interview that he made contact with on two occasions. At approximately 1000 Hrs, he directed to remove contraband from his cell. One hour later the Contraband was not removed. Neu said he instructed to surrender two magazines that was using to make Origami ties with, but refused.



#3 Neu related he never said, "Don't mess with the guys in black."

Laughing, Deputy Neu denied saying "Don't mess with the guys in the black!" Besides don't mess with the guys in black, Deputy Guitron said he heard him say "Don't fuck with the guys in black" or "Respect the men in black." Pg. 27 from Deputy Neu's transcript. 9.6 Departmental Investigations- Unethical Conduct and 9.7 Truthfulness

Deputy Neu denies talking to Deputy Guitron about this particular incident since 05/26/06. However, Deputy Guitron said Neu approached him sometime after Guitron's July 13th, 2006 interview and inquired why Guitron did not tell him (Neu) that he was interviewed. Neu asked Guitron what he told Internal Affairs. Neu apologizes to Guitron for placing him in this situation.
