SR. DEP. LUQUIN: Okay. We are on. Today's date is September 11, 2009. The time is 17:58 hours. I'm Senior Deputy Luquin. That's L-U-Q-U-I-N, star number 1815. Today, I am conducting an interview with, uh -- sir, spell out your last name.
