BACKGROUND

On March 16, 2020 I received a phone complaint from a parking ticket from an Officer Castagnola on March 13, 2020 at around 7:00pm. was upset that she had received a parking ticket while seated in her vehicle, while parked in a Handicap space at the Village Beach. Stated the officer scared her and she though he was harsh in the manner in which the officer dealt with her. I advised that I would investigate the matter, although indicated she was not perusing a personnel complaint against the officer. I apologized to for her perceived interaction with the officer. Stated she did not have a Handicap plaque displayed at the time of the incident, nor did she possess a permit)	
COMPLAINANT STATEMENT(S)	
On March 17, 2020 I initiated an investigation into involved interaction with a motorist, based on department policy, I first looked for body worn camera photage that may exist of the incident. In the course of researching Sergeant Jorge Castagnola's BWC photage for March 13, 2020, I came across video photage that indicates Sgt. Castagnola had inadvertently left his BWC on. In the course of doing so, Sgt. Castagnola documented his own misuse of a department MDT and unauthorized access to the internet for personnel use. (Eventually I did locate video photage of the encounter between and Sergeant Castagnola. The photage of this incident clearly demonstrated that Sergeant Castagnola conducted himself within the scope of his duties. I did not find Sergeant Castagnola to be immediately abrasive or demeaning to during their initial encounter, however incidental to receiving a traffic summons, did become argumentative with Sergeant Castagnola. I did find that Sergeant Castagnola's demeanor did change at this point, becoming somewhat curt with

LETTER OF CENSURE

On July 18, 2019 you appeared before me for informal Command Discipline regarding your watching of Netflix and the use of the department's Router for personal internet use while on duty, that occurred on several occasions between May 21, 2019 through June 19, 2019 (you were asked and waived union representation) An investigation completed by Lieutenant KJ Swart determined that while on duty you accessed the department's router for personal gain, use of internet access for the purpose of conducting other than official law enforcement business.

I advised you that in doing do, you violated several department policies, specifically SOPS 330.6; 330.10 and 790.00. You were also advised that the violation of SOP 330.10 (Insubordination) was the direct result of a previous counseling session in which you were admonished for using the department's internet at that time, for your personal benefit in uploading thousands of personal photos to the cloud. After providing opportunity for your response and input with respect to discipline in the matter, I informed you of my offer of a Letter of Censure and the forfeiture of two (2) accruel days. You have advised me that you accept the offer. Two (2) days of accrued time will be deducted from your accrual bank

I am glad you are taking full responsibility for this incident. You are a valued employee with this Department and I trust that the decision you made regarding this incident was a temporary lapse in judgment and will not be repeated in the future.
