Good morning Kimberly,

I see that REBOUND has sent you a request for our payroll records. I am not sure how much you know about these folks, but they are a private entity with no authority whatsoever, in spite of their claims to the contrary. Don't be fooled by their claims and implications....REBOUND is funded by the Contractors Union and is used by the Union to harass and destroy all non-union contractors, like us. We do not recognize REBOUND as an "Interested Party", and their mere unsubstantiated claim to be an "Interested Party" does not make it so. (Note that their claim is unsubstantiated). You do not have to provide REBOUND with anything. They are a PRIVATE entity, funded by the Union. Providing REBOUND with our payroll records only assists them in harassing contractors that you guys rely on to perform work on your projects.

REBOUND is usually notified about projects like this by a disgruntled Union contractor who is  $2^{nd}$  or  $3^{rd}$  low on the project. They report this to the Union, and since the Union cannot do anything about it themselves, the Union hides behind REBOUND and sicks REBOUND on the low, non-union contractor.
