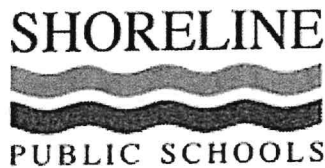

Dear Superintendent Miner:

This letter is a public disclosure request made by the Washington Education Association pursuant to Chapter 42.56 RCW, (Washington Public Records Act), for the following documents and public records believed to be in the possession or control of the Shoreline School District ("the District"), its agents, representatives or attorneys. Please direct this request to your public records officer.

Consistent with the letter and spirit of the Act, the following requests are to be broadly construed, and, if any exemptions are asserted, they should be narrowly and specifically defined, in detail sufficient to permit meaningful judicial review. See 42.56.210(3).

Specifically, if documents within the scope of the request below exist, but you maintain that they are exempt from public disclosure, specifically identify each such document; its subject matter; the date it was created; the author and all recipients thereof; and the specific statutory exemption upon which you are relying in refusing to provide the document, in whole or in part.

Please provide electronic copies of the following:

1. Any public records requests made by the Freedom Foundation from June 2018 to the present.
2. All public records provided to the Freedom Foundation in response to such request from June 2018 to the present. If the public records request requests an ongoing monthly request for responses, please provide us with copies of those future responses as well on an ongoing monthly basis.

Please note that the information requested above is not for any commercial purpose, and, that we are not requesting any personally identifiable student information. Also, to the extent multiple lists might exist, we are not requesting duplicative lists/information; we are requesting only one of any such list, or those portions of any records or lists that, collectively, would provide the same information as would a single, comprehensive list or record.

Please note that the term "public records" includes electronic files and records, such as emails or other computer files or records, in addition to hard/paper copies, and that RCW 42.56.520 requires a response to this request within five business days of its receipt.


