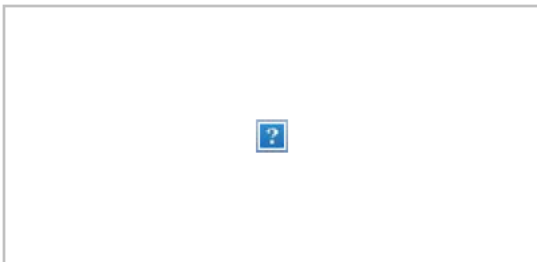
Hello,
