Short-Term Suspension Appeal Procedures

Definition: A short-term suspension is a suspension from school for (10) ten consecutive school days or less.

Pursuant to WAC 392-400-460, you and Chele here to enterior may attempt to resolve any disagreement with the District's disciplinary decision through an informal conference with Eric Cahan. You may request this conference either orally or in writing by contacting Sherri Pickett. At this conference, Eric Cahan will listen to your perspective and explanation regarding the behavioral violation, provide you the opportunity to confer with the school personnel involved in the incident and discuss other forms of discipline to address the behavioral violation.

Regardless of whether you elect to participate in an informal conference with Eric Cahan, pursuant to WAC 392-400-465, you have the right to request an appeal of the short-term suspension to the Superintendent or designee. To appeal the disciplinary decision, you must submit a written or oral request for appeal within five (5) school business days after your receipt of this letter to:
