## **DECLARATION OF COVERAGE**

**ENTITY:** City of Richmond

ADDRESS: 450 Civic Center Plaza

Richmond, CA 94804

COVERAGE PERIOD: July 1, 2020 to June 30, 2021

LIMIT OF COVERAGE: \$40,000,000, subject to a retained limit of \$500,000, ultimate net loss

for each occurrence as defined in the Memorandum of Coverage

## Sublimits:

(1) For **Employment Practices Liability**, the limit of coverage is \$5,000,000 in Pool C and \$5,000,000 in Pool D subject to a \$5,000,000 annual aggregate collectively in Pool D only, for all covered parties;

- (2) For **Subsidence**, the limit of coverage is \$5,000,000;
- (3) For **Fungal Pathogens**, the limit of coverage is \$5,000,000 in Pool C and \$5,000,000 in Pool D subject to a \$5,000,000 annual aggregate collectively in Pool D only, for all covered parties;
- (4) For **Sexual Abuse arising out of Day Care Operations**, the limit of coverage is \$5,000,000 in Pool C and \$5,000,000 in Pool D subject to a \$5,000,000 annual aggregate collectively in Pool D only, for all covered parties;
- (5) For Terrorism, the limit of coverage is \$5,000,000 in Pool C and \$5,000,000 in Pool D subject to a \$5,000,000 annual aggregate collectively in Pool D only, for all covered parties;
- (6) For **Airports**, the limit of coverage for *Public Officials Errors and Omissions* is \$5,000,000 under exclusion #2;
- (7) For exceptions to the **Pollution** exclusion #27, the limit of coverage is \$5,000,000;
- (8) For **Property of a Covered Party**, the limit of coverage is \$5,000,000 in Pool C and \$5,000,000 in Pool D subject to a \$5,000,000 annual aggregate collectively in Pool D only, for all covered parties; under exclusion #28.
