#### NOTIFICATION:

On 04/16/2017, at about 1330 hours, I was advised of an officer involved shooting. I responded to the SEB from home.

#### **INVESTIGATION:**

Prior to the briefing, I met with DOJ Technicians Meagan Gallagher, James Hamiel, and Anthony Sutter. They provided me with a DOJ report number of CV 17-2795. At about 1411 hours, we along with FET Mitchell conducted the firearm exchange with Officer R Johnson III (#1327). Also present was his attorney and SPOA Representative J Afanasiev. The exchange took place on the ground floor of the SEB in the sally port area.

Officer Johnson was photographed by both FET and DOJ. He was wearing his Class B uniform with visible Stockton PD patches. He was wearing a nylon duty belt and had two magazines on the left side of his hip. His holster hung slightly below the duty belt and was about hip level as opposed to waist level. In addition to his firearm and magazines, he had an ASP, keys, radio and pepper spray. He had a shoulder mic from his radio. There were no visible marks or injuries.

His magazines were inspected and both were filled to max capacity with 12 rounds in each. His firearm was a Sig Sauer P226, serial number U832085. It had a mounted flashlight. There was visible powder residue about the barrel. There was one round in the camber and 8 rounds in the magazine.

After his firearm was collected, I provided Ofc. Johnson with his loaner firearm and he signed the form acknowledging receipt of that weapon. I turned that form over to Sgt. Smith upon completion of the gun exchange at about 1424 hours.

The briefing was conducted at about 1730 hours. I was assigned to assist Detective Porta on Team 3 with processing the scene. Team 3 included Ofc. Mauldin from CII and DAI investigator Paine. Refer to his supplemental regarding the scene report.

garage door was opened. I couldn't find a location matching that address. The residence at didn't have a garage door and I didn't receive any answer when I knocked on the door.

After the processing of the scene was completed, I drove Officer Johnson and Rodriguez' patrol car back to the SPD lot. I removed their personal property from the vehicle and left them in the secondary sergeant's office.

On 04/18/2017, I authored a search warrant for the Dodge Durango that was towed by Technique Towing. The warrant was granted by the Honorable Judge Elizabeth Humphreys. Officer Porta, Officer Wright, DAI Paine and I went to Technique Tow to process the vehicle. Refer to Det. Porta's report for further information.

Detective Dewing authored a search warrant for and Edgar's residence. We executed the warrant on 04/20/2017. I was assigned to be the finder during the search. The finder's responsibility is to document the search as well as the items seized pursuant to the warrant. The search team consisted of Sgt. Smith, Det. Dewing, Det. Porta, DAI K. Locaso, and Ofc. Wright (CII). FET K. Rash, 2L21, responded for evidence collection and documentation via photographs.

The residence was a single story family residence. There were two bedrooms, a single living room, a kitchen/dining area and attached laundry room. There also was an attic that was accessible via the main hallway area. The rooms were labeled A-G for easier identification and overalls of the location were taken prior to searching.

Nothing was collected from room "A", the living room, but a Green Bay Packers hat was photographed that was on a speaker on the west side of the living room entertainment center. Within the entertainment center was a book about Aztecs, which was also photographed.

In room "D", the north bedroom, there was a red and black cooler found on the top shelf of the closet on the east half. Inside the cooler was a white sock that contained 22 .223 rounds. Also inside of the cooler was a box of 9mm luger bullets, Federal ammunition brand and labeled range target practice. There were 11 bullets inside of the box. In addition, there was a black extended capacity magazine that contained at minimal 17 rounds. The bullets weren't removed and counted at this time as FET was going to process the magazine, thus manipulation of the item was kept to a reasonable minimum. There was also a digital scale at the bottom of this cooler. The sock containing the bullets, the box of ammunition and magazine were all collected by FET Rash.

It was noted that while going through the closet, it appeared that items on the west half of the closet was primarily male clothing and clothing on the east side was primarily female. Red was a prominent color in regards to the male clothing and hats in the closet. Photographs were taken of the closet to document. There was also a large carbon fiber backpack that had indicia for Edgar. There was also some indicia with Edgar's name in the plastic bins on the west side of the room which were documented via photograph.

In room "E", the west bedroom, there was a gray colored shoebox located in the bedroom closet. In that box was some marijuana in four separate packages, paper work for the separate packaging and a fixed blade "claw" type weapon. The weapon was collected by FET Rash.

In room "F", the bathroom, the victim's medical bracelet from the hospital from the night of the incident was located. It was simply photographed.

Exit photographs were taken of the residence. The victim was given a copy of the affidavit, the search warrant notification and copy of the property receipt by placing them on the dining room table in her presence. While we were searching the residence, the victim was notified of the search warrant I wrote covering the Durango by Det. Donovan. That warrant included language authorizing the search of her cellular phone that was recovered therein.

NOTIFICATION:	

On 4/16/17 at about 1330 hours I, Detective Porta (I-23) was contacted at home regarding an Officer involved shooting that occurred in the area of Filbert Street and Washington Street. I was requested to respond to the Stewart Eberhardt Building (SEB). I responded from home and arrived at the SEB at approximately 1445 hours.

#### **INVESTIGATION:**

(It should be noted that any measurements listed within the following report are used merely as a means of estimation in order to better describe observations made. For more exact measurements and distances refer to the scene sketch)

Prior to the briefing I conducted follow up on the case based upon the call history and a summary of the incident given to me by Sergeant C. Smith (I-2). Initial information provided to me from Sergeant Smith was that Officers R. Johnson and B. Rodriguez (2D25) responded to the area of South Filbert Street and East Washington Street for a report of a possible family disturbance in progress. Shortly after arrival, Officer Johnson discharged his firearm after the male half involved struck a patrol car and a citizen's vehicle with his own.

Per the call history a female, later identified as VIC, advised her boyfriend hit her and was following her in a white Dodge Durango with a license plate of . The female advised that she had to borrow a stranger's phone and was yelling for the male to get away from her. Officers Johnson and Rodriguez arrived at approximately 1309 hours and advised of shots fired at approximately 1311 hours. Per the call history I learned that the potential suspect was Edgar Montoya 11/19/90.

Prior to briefing I called Manteca Police Department as the Durango involved was registered to
in Manteca, CA. Manteca PD Records had no prior calls regarding VIC at
however, had a prior application for a Domestic Violence restraining order filed against him in 2014 from another
female ). There were no prior records or calls for service involving the white Dodge
Durango ( ) or involving Montoya and VIC.
I then assisted in gathering a list of potential witnesses. I spoke with Officer Cortes (2A43) who had responded to
the incident as it happened and spoke with several witnesses. Cortez advised me that there was one occupant of
the Nissan who was struck by Montoya's vehicle, who was transported to the SEB. Cortes also
spoke to at the scene who was at the corner of Filbert Street and Washington Street when the

incident took place. Cortez further spoke to

the incident. Refer to Cortes' report for further details on his investigation.

I attended a briefing that occurred at approximately 1730 hours. The briefing included members from the District Attorney's office, Department of Justice, and other members of the Stockton Police Department. I was assigned to team 3 whose primary responsibility was the documentation of the crime scene. Other members assigned to team 3 were as follows; DAI investigator Robert Paine and CII officer Cooper Mauldin. DOJ investigators Meagan Gallagher, James Hamiel and Anthony Sutter also assisted in the investigation. Detective Mohammed assisted me in the investigation as well, refer to his supplemental report for details.

The briefing was led by Lieutenant Doberneck who advised that the call was initiated at approximately 1305 hours and Officers Johnson and Rodriguez went on scene at approximately 1309 hours. They then aired that they were rammed at approximately 1310 hours. Shots were fired and the suspect was ultimately found to be conscious and talking. The suspect was transported to UC Davis Hospital with a gunshot wound to the head. The victim was

transported to Dameron Hospital.

During the briefing I viewed Officer Johnson's body camera footage. During the video I saw that Officer Johnson was seated in the passenger seat of the patrol car as they arrived. Upon arrival, Officer Johnson approached the passenger side of a white Dodge Durango. Officer Johnson appeared to give orders to the occupant of the vehicle and also speak to his partner. The apparent sole occupant in the driver's seat of the Durango did not exit the vehicle. Instead the vehicle drove forward, colliding with Officer Johnson and Rodriguez's patrol vehicle. The Durango then went into reverse colliding with a vehicle stopped in the street behind the Durango. The Durango then drove forward again, ultimately colliding with the same patrol car again. While the vehicle drove forward the second time, Officer Johnson discharged his firearm four times.

After briefing I responded to the scene and arrived at approximately 1806 hours.

#### WEATHER:

The weather upon arriving at the scene was approximately 55 degrees Fahrenheit according to Accuweather. It was overcast and rainy conditions. The rain would fluctuate from none to a light drizzle to heavy throughout the investigation. The street was wet upon my arrival as it had been raining throughout the day. Due to the rainy conditions, the Dodge Durango was later towed from the scene prior to any searching or processing.

#### **PERIMETER:**

The perimeter was blocked off at East Market Street and South Filbert Street to the north. The southern edge of the perimeter was located at Lafayette Street and Filbert Street. The eastern edge of the crime scene was naturally blocked by the wrought iron gate running along the west side of the apartment complex (Village East Apartments). The western edge of the crime scene ran north/south across East Washington Street approximately five houses west of Filbert Street.

The crime scene perimeter was made very large in order to control traffic more efficiently. The inner area of the perimeter surrounded the immediate area of the intersection of Filbert Street and Washington Street. The inner area was not delineated or marked by crime scene tape, however the pertinent area of the scene was located within a small area near the north west corner of the intersection.

There were numerous vehicles parked along the eastern sidewalk of Filbert Street in between Market Street and Lafayette Street that were not involved in or effected by the incident. Those vehicles will not be included in this scene report. The vehicles (both city and civilian) and evidence located at the intersection of Filbert Street and Washington Street and east along Washington Street will be documented. No items of evidentiary value or pertinence were located outside of the mentioned area.

I entered the crimes scene from the north at the intersection of East Market Street and South Filbert Street. The crime scene tape was connected to the wrought iron fencing surrounding 111 South Filbert Street at the south west corner of Filbert and Market Streets. The tape stretched east across Filbert Street, bypassing city light pole #1878E. The tape was attached to a "No Left Turn" sign in the middle of Filbert Street. The tape continued across Filbert to the east side walk and connected to the black wrought iron fencing along the west side of the apartment complex which encompasses 104 S Filbert Street. Marked Stockton Police Department unit 4019 was parked at the northern perimeter and under Control of (2M60) Keener.

Officer Blakeslee was parked in his marked police vehicle (City vehicle number 4112 with CA plate #1498352) and was manning the crime scene log. I signed in with Officer Blakeslee at 1807 hours. Officer Blakeslee also manned the eastern edge of the perimeter.

The southern crime scene tape ran across Filbert Street, parallel to the northern curb line of Lafayette Street. The crime scene tape was attached on the east to a black wrought iron gate along the west side of the apartment complex which encompasses 242 S Filbert Street. The tape was attached at the north east corner of the intersection just south of Stockton city light pole #10971 with "400" written underneath. The tape ran west across Filbert Street to the North West corner of the intersection of Filbert and Lafayette. The tape was attached to a black wrought iron gate located to the south east of 2495 and 2497 E Lafayette Street. Marked City Community Service Officer vehicle 3617 manned by CSO Bale (2C11) was parked along the southern perimeter of the crime

scene.

The crime scene tape on west side ran north across Washington Street in between residences 2464 E Washington Street (South) and in front of 2459 E Washington Street (North). The south end of the tape was attached to a chain link fence in front of 2464. The north end of the tape was attached to a tree, south of 2459 and then from the tree it was attached to the front yard fence in front of 2459. CSO vehicle 3616 was parked along the west perimeter and was manned by (3C9) CSO Buell.

#### LIGHTING:

The closest street light (#795 with "400" written below) to the scene was located at the south west corner of Washington Street and Filbert Streets. Upon arriving at the scene there were no street lights or house lights on. As the incident occurred during early afternoon hours, street lights would not have been a factor.

#### **VEHICLES:**

Filbert Street: (City vehicles or vehicles assisting with investigation but not directly involved in incident)

The Stockton Police Department Mobile Command Unit was non operative at the time of this investigation. The Stockton Fire Department Hazardous Materials Response Team vehicle (City vehicle 5505, CA plate # 1425866) was deployed and parked north of Washington Street on Filbert Street. The purpose of the vehicle was to mainly provide shelter during the rain.

FET Rash had originally responded to the scene and conducted a preliminary photo/video documentation of the scene. FET Rash was securing from the scene shortly after I arrived. Her city vehicle number was 4152. FET Adams arrived at approximately the same time I arrived on scene in city vehicle 4155. ### Dodge. SCENE:

Upon initially walking through the crime scene I observed that Filbert Street is a wide two lane street running north/south which opens up to both residential and commercial areas. Filbert Street is controlled by a traffic light at the intersection with Market Street to the north and Lafayette Street to the south. Washington Street is a narrow two lane residential street running east/west. The intersection of Washington Street and Filbert Street is controlled by a stop sign located at the south west corner of the intersection.

facing south west across Washington Street at the intersection with Filbert Street. The rear passenger side bumper appeared to be pushed up against the rear passenger side tire and rear passenger side door of the

123 South Filbert Street is the residence located at the north west corner of intersection. The residence was surrounded by a white wrought iron fence along the perimeter to the south and the east. The residence is situated along the northern end of the property. There is a large amount of grass and yard space to the south which butts up to the northern curb line of Washington Street.

At the north west corner of the intersection of Filbert and Washington Streets I observed SPD unit 4115 facing south west with the passenger side tires slightly on the curb. The front passenger side of the front push bumper of SPD unit 4115 (Ford SUV model) appeared to be in contact with the middle area of the front bumper of the White Dodge Durango. Unit 4115 was logged in to (2D23) Officers Serna and Adams.

SPD unit 4116 was parked facing south west and located east of SPD unit 4115. Unit 4116 was almost parallel to Unit 4115. The rear hatch of Unit 4116 was open upon my arrival. Unit 4116 was logged into (2D33) Officers McPherson and Twigg.

just west of the west curb line of Filbert Street. The rear passenger side bumper of unit 3877 was in contact with the rear passenger side door and rear passenger side tire of the Dodge. Unit 3877 was running upon my arrival and both the headlights and taillights were on. There appeared to be white scratch marks which could have possibly been paint transfer along the passenger side of the front bumper. The passenger side of the front push bumper also appeared to have been bent inward. The passenger side of the rear bumper of unit 3877 appeared to be dented inwards where it was in contact with the Dodge. Unit 3877 was logged into (2D25) Officers Johnson and Rodriguez. Inside the cab of unit 3877 was Rifle #13 secured in the gunlock.

The engine of the Dodge was running. I could see that the driver's side door of the vehicle was open, along with the trunk hatch. Inside of the rear hatch there were two Kicker subwoofers in a speaker box. There was also a leather cd type case sitting in the rear cargo area. The front bumper on the driver's side near the fog light appeared to have a small crack and possibly black paint transfer. The front passenger side of the bumper also had what appeared to be black smudges or possible paint transfer along the passenger side of the front bumper and along the front passenger side fender. A section of the front passenger side wheel appeared to be missing or cracked. I also observed what appeared to be small black horizontal linear scratches on the rear side of the front passenger side tire fender. The rear passenger side bumper appeared to have been cracked. There was what appeared to be a black rubber type cover which ran along the top rear bumper. On the passenger side of the bumper above where it was cracked, there were several gray colored pieces of what appeared to paint chips (Later labeled with placard "5"). The paint chips appeared to match the color of the gray colored Nissan (CA plate cated west of where the Dodge was located. The center of the rear bumper also appeared to have a small amount of damage or a crack.

The driver's side of the Dodge had what appeared to be 4 separate bullet strikes. The bullet strikes were later designated letters by DOJ (Refer to DOJ report for more details on bullet strikes and trajectories). The driver's side door had two separate strikes, the first of which was just below the window frame in the center of the door (Later designated as A1). The window was rolled up approximately 6 inches and it appeared to be cracked. On the interior of the driver's side door panel there was a hole in the approximate area of the hole on the outer portion of the door. As you looked across the passenger compartment to the passenger side, near the "B" pillar there appeared to be a mark on the front passenger's seatbelt which appeared to be consistent with a bullet strike (A2). The driver's side exterior door handle was broken and chipped off in a round shape (B). The frame of the door handle where it met up to the door had a hole which appeared to bend the metal beneath the handle inward. There did not appear to be an exit hole in the interior of the door panel that met up with the exterior hole.

The area where the driver's door and the rear driver's side door meet on the "B" pillar of the vehicle appeared to have been struck (C). Approximately 6 inches above the bottom of the window frame there appeared to be freshly uncovered metal where the paint had chipped away. The metal on the door frame appeared to be warped along with an area on the driver's side door. It initially appeared to me that a bullet had struck the edge of the driver's side door, bending the door frame, but never penetrated through the door. There were also what appeared to be white paint chips along the ground beneath the door. The rear driver's side passenger window was broken. There was a circular hole which appeared to be consistent with a bullet strike along with a larger, more triangular section of glass broken away as well (D).

Standing near the open door of the Dodge and looking into the passenger compartment I could see what appeared to be broken, tinted glass along the driver's side floorboard and running board. The front driver's and passenger's side windows of the Dodge were not tinted. The rear passenger side windows and rear hatch window were tinted. The radio and internal temperature control panel appeared to have been separated from the rest of the dash. There was also what appeared to be blood on the driver's seat and the driver's seat belt receptor.

West from the Dodge, along the north side walk of Washington Street there was a small tree. Located just west of the tree along the north curb line was a yellow colored older model Chevrolet pickup.

There was another tree located further west along the north sidewalk of Washington Street near where the properties of 123 South Filbert Street and 2485 East Washington Street meet. Approximately 6 feet south of the north curb line of Washington Street, near where the aforementioned tree was located along the sidewalk, there

was a silver colored casing located in the street. Four casings were ultimately located in the street. This northernmost casing was labeled with Placard "1".

Approximately 5 feet to the south east of the first casing, another silver casing was located. This casing was labeled with placard "2". A third casing was located approximately 4 feet to the south west of the second casing. This third casing was labeled with placard "3". The fourth casing was located approximately 15 feet to the south east of the third casing. The fourth casing was located north of 2498 East Washington Street in the street. The fourth casing was labeled with placard "4". All casings located were found to be "FEDERAL 40 S&W". All casings were located in the street and originally marked by responding officers with SPD paper report cards. Due to the weather the cards became wet and soggy. Additionally, there was what appeared to be some sort of soggy tissue type paper and a plastic wrapper located in the street in the same vicinity as the first casing labeled. It should be noted that the placards do not indicate the order the casings were found, they are used to document the evidence with more efficiency and organization.

There was a Silver 2009 Nissan Sentra bearing California license plate parked partially in the driveway of 2485 East Washington Street. The rear end of the vehicle up to almost the driver's side door remained in the street while the front end of the vehicle was on the sidewalk and in the driveway of 2485. The front end of the vehicle had what appeared to be significant damage. The hood was bent forming a sort of "U" shape. The front bumper was dented inward and appeared to have partially separated and hung lower on the driver's side. The headlights were out of alignment and the front fenders near the headlights appeared to be bent out of shape. The driver's side fender appeared to have been pushed up against the front driver's side tire. The front plastic grill appeared to be missing the front emblem and trim. The radiator also appeared to have been pushed inward and dented.

Located in the street to the south of where the Nissan was parked was what appeared to be vehicle debris. There were to be several small black plastic screw type pieces which are commonly used to attach vehicle trim pieces and fascia together. There was also what appeared to be silver colored front grill trim pieces and clear lens pieces laying in the street.

Due to the weather it was decided that the Dodge would be towed and processed after it was stored inside. Upon reversing Unit 4115, which had originally been in contact with the Dodge, the Dodge crept forward. It was found that the Dodge had still been in drive while it was running. After moving the vehicles apart, there were scratches located on the front push bumper of unit 4115 where it had contacted the front bumper of the Dodge. There were also what appeared to be smudge marks amongst the dirt and dust on the front bumper of the Dodge where the push bumper had been in contact with it. After moving Unit 3877 away from the Dodge it was evident that there was white paint transfer on the rear passenger side bumper and the bumper was dented.

When the Dodge moved forward after backing Unit 4115 away, it revealed the gutter near where the front driver's side tire of the Dodge had originally been. Located in the gutter was a copper jacket of an expended bullet. The copper jacket was labeled with placard "6". FET Adams photographed and later collected all the evidence from the scene. Refer to FET Adams supplemental report for further details.

The Dodge was towed away from the scene by Technique Towing and stored inside. Officer Roberson followed the vehicle and ensured that it was towed and stored appropriately.

I secured from the scene at approximately 2200 hours after advising that the perimeter could be broken down. I took over the crime from Officer Blakeslee.

technique towing in order to search the vehicle. The search of the Dodge was conducted after Detective Mohammed secured a search warrant which was signed by the Honorable Judge Humphreys on 4/18/17.

The rear driver side passenger window had more glass missing than it originally did on scene. FET Broussard took overall photographs of the vehicle inside of the ware house prior to our search. Inside of the front passenger doorway along the floor near the running board there was what appeared to be a red substance. This was later determined to be residue from flaming hot Cheetos after I located an empty bag of Cheetos near the rear of the front passenger's seat.

Located on the passenger side floorboard was what appeared to be an expended bullet. There was a black and brown colored plastic toy gun located under the driver's seat. The gun was visible as I opened the rear driver's side door and looked at the floorboard. There was dark colored broken glass all about the floor of the rear passenger area. The center console had a cup holder on the back which was accessible to the second row of seats (There were three rows of seats inside of the Durango). Inside of the cup holder was a green cup. There was what appeared to be a large pool of coagulated, dark blood along the floor near the rear of the center console and on and around the green cup.

The front radio/temperature control panel was loose and separated from the rest of the dash. This was the same position it was in on scene. The panel easily pulled away from the dash revealing a large cavity beneath the radio inside of the dash. The panel slides into place amongst the dash with a series of "clips" and that meet up to rectangular shaped holes in the dash. The holes and clips appeared to be very worn down and scratched and did not lock into place. Once the panel was pulled away it revealed what appeared to be a black colored extended pistol magazine attached to a silver colored semi-automatic handgun. The barrel of the handgun was pointed towards the passenger side of the vehicle with the grip closest to the driver's side. After removing the handgun from the center console it was rendered safe by Detective Mohammed. The handgun was found to be a silver colored Taurus PT 92 AFS semi-automatic with black grips. The magazine was loaded with 29, 9 mm Luger rounds and one 9 mm Luger round was located inside of the chamber. The serial number of the firearm, was TVG28266 and found to have no record.

One black LG cellular smart phone was located underneath the passenger seat by Detective Mohammed.

The third row of seats had what appeared to be a car seat and a booster seat for children and possible camping style chairs in red bags.

In the front center pocket area in front of the center console was a black bag. Inside if the black bag was half empty bottle of E&J Brandy (Not collected).

While removing the screws from the driver side door panel and attempting to remove the panel I noticed a silver colored apparent expended bullet fragment on the ground below the door. I then noticed what appeared to be a silver colored fragment on the driver's running board. After removing the driver side door panel I observed what appeared to be a copper colored expended bullet inside of the door well. The interior plastic of the door panel did not appear to be punctured. I removed three large screws behind the door handle and two smaller screws at the base of the interior door panel.

FET Broussard took swabs of apparent blood located on the rear floorboard behind the center console, on the driver's seatbelt receptor and from the steering wheel. The keys for the vehicle were in the ignition on a black Raiders lanyard. In addition to the car key there were several other keys.

A copy of the search warrant was left inside of the vehicle along with a property receipt for the items taken. All evidence located within the vehicle was collected and booked by FET. Broussard, refer to her supplemental for further details.

Officer Wright on 4/18/17. Detective Mohammed also assisted in attempting to copy the video to a flash drive. After originally copying the video we responded back to the SEB but found that the video did not copy correctly and would not play.

On 4/18/17 we also responded to a camera in front of the residence. In order to copy possible video/audio from a camera in front of the residence. In order to copy possible video/audio from a supprximately 5 houses west of Filbert Street along teh south side of Washington Street. We contacted who allowed us access to his Bunker Hill Security system. The system had printed on it "H.264 8 CH Digital Video Recorder" and was hooked up to a "Symphonic" TV screen. Detective Mohammed copied possible video files from the system covering the approximate time of the incident.

The system showed the correct date (4/18/17) but showed a time of "01:59" at 1334 hours (Estimated to be approximately 25 minutes fast). Upon later review there was nothing captured by the camera, the footage only shows the driveway of ... At approximately 01:22 hours and shortly after I could hear faint voices, possibly a male and a female, and they sound like they are loud, but from a distance. There is also what sounds like possible lawn equipment in the background at the same time the voices are speaking. The camera had an audio function which upon listening, I could hear at approximately 01:24:30 hours on camera time, the sound of an engine revving. At approximately 01:24:57 and 01:25:11 I could hear what sounded like a females voice yelling "Fuck you" followed by an unknown phrase ending with "Right". Again at 01:25:57 approximately I could hear the females voice again saying something like "Get the fuck out of here". Around 01:28 you can hear dogs barking and what sounds like faint voices in the background. At approximately 1:30:11, I could hear what sounded like a females voice saying "What" and a very loud sound that resembled tires screaching. Nothing is captured on the actual screen during these times however. At approximately 01:35:40 hours you can hear the sound of tires screaching and loud pops which could have possibly been gunshots. The recording was later booked into evidence.

I made further arrangements with to go back to her house on 4/25/17 at approximately 1500 hours with DAI Paine and CII Officer GarciaRangel. We collected the video surveillance unit after signed a consent form (Booked under this DR). We responded back to the SEB where Detective Estrada assisted in copying the video.

The video surveillance unit was found to be "Q-SEE" system and showed a time of 1710 hours at 1644 hours (Approximately 26 minutes difference). Channels #1 and #2 were recorded from 1300 hours to 1400 hours. In the video the Dodge shows up at approximately 1330 hours and is seen reversing and driving west along Washington Street. A short time later a Hispanic female is observed walking east along Washington Street followed by a Hispanic male with long hair in a ponytail. After walking after the female the male runs back west out of the camera view. The white Dodge can then be seen driving east along Washington Street towards the intersection with Filbert Street.

There appears to be some interaction with another person near Filbert Street. You can see a police car arrive a short time later and then the Dodge is seen driving forward, reversing and then driving forward again before stopping.

After downloading the video I returned the surveillance system to on 4/25/17. A copy of the video surveillance was booked under property tag #B123163.

Upon review of the crime scene log I contacted Stockton Fire Department's dispatch and found that MEDIC #103 had originally responded and taken VIC to Dameron. Medic #29 arrived on scene and transported Montoya. Stockton Fire units Battallion 1, Engine 3 and Engine 12 all responded to the scene. Engine 12 assisted in bringing the HAZMAT unit (Hazmat 3). The in and out times of all the listed people were listed on the log and booked into evidence under this report number.
