As per Sgt. Tarantino's orders I am writing this special report regarding Incident 3172-14. At approximately 1715 hours on 06/19/2014 I was on patrol eastbound on Lafayette Ave in Unit 473 approaching Chestnut St. I observed a black Acura four door sedan operating westbound on Lafayette Ave make a right turn onto Chestnut St and go north. When the vehicle was making the turn I observed the rear windows, which were half open, were tinted. I followed the vehicle up Chestnut St onto Wayne Ave and performed a traffic stop where I felt there was enough room for traffic to pass. The vehicle pulled over into the cutout next to the NYS Thruway just east of Washington Ave.

The driver acknowledged that her windows were tinted, but claimed that she had the old tints removed and replaced with lighter ones that she had been assured were legal. I got the tint meter from my car and put it on the rear left window. I did not have to instruct to lower or raise the window because it was in the same half-open position I had seen it in when she made the turn off Lafayette Ave. The window tested at 15% light transmittance. I then asked to raise the front driver's side window halfway up so I could test it. It registered 17% light transmittance. was issued summonses for tinted windows.
