This letter responds to your August 27, 2020, Freedom of Information Act (FOIA), Case number DLA-2021-000618, for “any contracts and agreements...involving/provided by/contracted for regarding Delta Crescent Energy, LLC”.

Pursuant to your request, we have conducted a search on your behalf. The agency has determined that it has no records responsive to your request.

You have the right to appeal this no records denial. An appeal must be made in writing to DLA FOIA Appellate Authority within 90 calendar days from the date of this letter, and no later than 5:00 pm Eastern Standard Time. The appeal should include your reasons for reconsideration and enclose a copy of this letter. An appeal may be submitted on <https://foiaonline.gov>, or mailed. Appeals are to be addressed to the Information Governance and Compliance Office, Defense Logistics Agency, Suite 1326, ATTN: FOIA Appeal (J67CC), 8725 John J. Kingman Road, Fort Belvoir, Virginia 22060-6221.

This agency decision concludes the processing of your request(s) referred to above. As part of the 2007 FOIA amendments, the Office of Government Information Services (OGIS) was created to offer mediation services. Similarly, as part of the FOIA Improvement Act of 2016, DLA established a FOIA Public Liaison to offer mediation services.

Both OGIS and the DLA Public Liaison will assist in resolving disputes between FOIA requesters and DLA as a non-exclusive alternative to appeal. Using OGIS or the DLA FOIA Public Liaison does not affect your right to pursue appeal nor does it stay the appeal clock.
