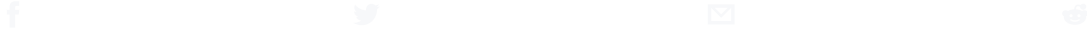

In response to the April 9, 2018 email sent by Ryan Yates, I wish to appeal the decision to unilaterally close my request. As you can see by <https://www.muckrock.com/foi/united-states-of-america-10/reeses-for-pai-48340/>, I sent numerous follow-up emails and made numerous attempts to clarify the request, specifically, FCC-2018-000371 and FOIA Control No. 2018-353.

To date, I have not received the requested documents for EITHER of the request. And evidence of the email records clearly shows that I responded to the inquiries by the FCC in a timely manner. The method of emails and communication was in line with the Freedom of Information Act request guidelines and was made without delay. I do not believe the actions of the FCC are correct and wish for my requests to be immediately re-opened. Even if the FCC did not receive my emails (which the FCC did) it would not be appropriate for the FCC to close both of the requests as they were adequately described and reasonable requests.
