This is in response to your Freedom of Information Act (FOIA) request received May 12, 2023, in which you sought to obtain; *"Records related to the use of Unmanned Aerial Vehicles (UAVs) or drones during President Trump's administration in the Philippines, including drone readiness documents, mission plans, flight logs, and maintenance records, inspection records."*

U.S. Indo-Pacific Command has conducted a search of its records but did not locate any responsive records to your request.

You must also include copies of all correspondence between you and USINDOPACOM concerning your FOIA request, including your original request, your reference ID 2023-F-070 and USINDOPACOM's response. Lastly, include your name and daytime telephone number (or the name and telephone number of an appropriate contact), and email address in case the FOIA Appeals Officer needs additional information or clarification of your appeal.
