## NARRATIVE

On 04/08/2023, at 14:00 Hours I responded to 32 Claremont Ave in reference to a UUV that just occurred.

Patrol on scene at 32 Claremont Ave advised that the owner of the vehicle (Alexis Rose) was tracking her 2023 black Audi Q5 (NY# KVF7233) on her phone and said it was stationary at 572 Colvin Blvd in Buffalo, NY. Patrol located the vehicle at this address unoccupied. I captured on my body worn camera no damage to the exterior or interior of the vehicle. Clarence Houston (Fiance of Rose) arrived on scene at Colvin Blvd and took custody of the vehicle and drove it back to Claremont Ave.

Rose said that she left her key fob inside the vehicle, parked, outside of the house. I captured on my BWC video footage from a ring doorbell at 30 Claremont Ave of a black Dodge Ram parked in front of 30 Claremont Ave, but was unable to identify any occupants. The neighbor advised he saw 2 black male occupants inside of the pickup truck and could be the suspects.

Rose said that her Louis Vuitton purse worth \$1,700 was missing from her vehicle. Inside of the purse was her NYS driver's license, social security card, a ring worth \$1,100 and multiple debit/credit cards.

Rose stated that the listed debit/credit cards were used at 2058 Delaware Ave (Speedway) at approximately 14:04 Hours:

Rose was advised to cancel/freeze all accounts. Rose was left a complaint card and advised on how to obtain a copy of
