Narrative

On 06/25/21 at approx. 1700 hrs. I was contacted by dispatch for a call transfer. The caller was a Park Ranger from Yosemite advising they had located a body in a river and they would need transport from Tuolumne Meadows Ranger Station in a few hours. They said they would call me back when they were ready. I advised dispatch of this and prepared to go. I was recontacted by Rangers at approx. 1812 hrs. and advised the body was ready for pick up. I advised TCSO dispatch of this.

Upon arrival I spoke with Ranger Tim Knaus who had been at the scene of the recovery. He told me the area was very remote and described a granite slope with a river flowing down its face. The granite is slippery and he believes the decedent slipped and fell into the water and was swept approx. 200 feet down where his body came to rest in an eddy. The decedent was in a small building on the station grounds. I went into the building and saw a black body bag on the floor. I opened the bag and saw the decedent was a white male approx. 60 yoa wearing typical hiker attire. All his gear was in the body bag. The Rangers had searched some of the gear for ID but did not find any. A car believed to belong to the decedent was found in the area. A Cal ID photo of the R/O was compared with the decedent. There were definite similarities but not enough to be conclusive. I took several photos of the decedent. The body was face down in the bag. I turned him over and checked for tattoos and injuries. There were large bruises and scrapes on his forearms and face. The left eye was very bruised and swollen. There were also minor lacerations on his hands. The injuries were consistent with a fall from height. The contents of the equipment was searched again but no identification was found. The equipment was placed back in the body bag. I removed a watch and a wedding band from the body and gave them to Ranger Knaus for return to the NOK.

The bag was sealed and loaded into the coroner truck. I transported the decedent to the TCCF where I applied a tag labeled John Doe with the case number 21-2083. I also took thumb prints for later ID. The decedent will undergo an autopsy at SCCF. This case is pending those results.
