

#### **Summary:**

Ryan Douglas Williams died as a result of a rock climbing accident at Yosemite National Park.

### **Investigation:**

On 9/10/21, at approximately 1425 hours, I was dispatched to Yosemite National Park, Yosemite, for a report of a death. I arrived at the Tuolumne Ranger Station and met with Yosemite National Park Investigator Tim Knaus. Inv. Knaus explained that he responded to Doda Dome, located at Lat 37.878510, Lon -119.412660, for a report of a climbing accident. Upon arrival, it was discovered that Ryan Douglas Williams was deceased.

Inv. Knaus provided the following information:

The decedent and his girlfriend, Sarah Alyssa Howards, were at Doda Dome. The decedent was going to rappel down a part of Doda dome while Howards had a harness with a rope attachment and a braking system. There was an error while the decedent began rappelling down the rock wall and the decedent fell between 55 and 60 feet to his death. See Yosemite National Parks Case number 20210910-023 for additional details.

I examined the decedent, which was moved from the accident site to a secure location prior to my arrival. The decedent was currently inside of a black body bag during my inspection. The decedent was covered in blood and appeared to have trauma to the back of his head. Locating the injuries exact location was difficult to find due to the amount of blood and the thickness and length of the decedents hair.

I took photographs, collected fingerprints and placed an identification tag on the decedents right ankle. All of the decedent's property on his person was turned over to Inv. Knaus.

Inv. Knaus explained that a death notification was completed at approximately 1630 hours to the decedent's mother, Lauri Issacson. He provided me with her contact information and Doug Williams contact information, who is the decedents father.

I transported the decedent to the decedent to the TCCF. On 9/14/21, Deputy Christiansen transported the decedent to the SCCF for an autopsy. At the conclusion of the autopsy, the decedent was released to the Allan Mortuary per the request of Doug Williams.
