First and foremost, I would like to thank everyone for their participation in the City of Mobile and ShotSpotter "data for good" collaborative platform demonstration. As we move forward to create a more holistic response to identify,



respond, and mitigate violence, your continued input is greatly needed. As we build this sharable database, I'm requesting that you assist by sharing your thoughts about what the platform should do and consist of. I'm also requesting that you share what data will be permissible by your agency to share and with whom the data can be shared with. For this platform, "data for good" is about having a collective impact toward healthier outcomes in the case management of individuals and families being served in the community by local, state, and federal agencies, often at the same time.

Although the vision and focus for the platform is multi-discipline, some data will be limited to only agencies that have a "need to know" that's in the best interest of the individual and that of public safety.
