I added an overarching statement in new 2. O regarding the context of this agreement and its interpretation that I think even standing alone should get us there.

I made the indemnity provision mutual.

I left the Contractor with ownership of the Custom Deliverables.

Because this is an emergency procurement, many sections, like E-Verify, are not applicable. Because of the nature of the Services, other sections, like criminal background checks for admittance to secure state facilities, are not going to apply. And there is no question if I had more time I could do a far better job. However, given the urgency, I decided not to try to delete the inapplicable provisions or lawyer this to death.

As noted, I think section 2. O contains the essence – the State's T&C's were drafted for the protection of the State, this is an emergency, the Contractor has forgone the opportunity to negotiate because of the emergency and the overarching principle is that the Contractor be treated fairly.



Thanks for your patience as I caught up and consulted with our people on your question. Our interpretation is that the pricing information on Attachment C would not be treated as a protected document. There are a few reasons for this. GRAMA Section 201 is clear in 2(J) "Documentation of the compensation that a governmental entity pays to a contractor or private provider" is public information. That said If they can justify any other parts of the contract needing to be protected pursuant to Utah Code §§ 63G-2-305(1) or (2), we would be happy to take that into consideration.
