In response to your Freedom of Information Act Request dated April 13, 2019 concerning the above request, please find enclosed the requested documents. Please note that certain information has been redacted pursuant to § 2.2-3815 (social security numbers), § 46.2-208 (drivers' license numbers), and/or § 2.2-3706(D) which states "materials that contain identifying information of a personal, medical, or financial nature may be withheld where the release of such information would jeopardize the safety or privacy of any person." Some of the information that you requested is no longer available and can no longer be provided.

In addition pursuant to Virginia Code § 2.2-3704(B)(3), the request for closure date for missing persons is not a record that we record and you will need to contact the reporting agency for that information. 
