Sou went missing, She was drinking and took off walking down the road as she has done in the past

I attempted to call her phone to find her. No Answer

I called the sheriff

They took a report and left

I then get a call from her number, threatening to sell her into sex slavery by unknown man

I call the sheriff back and report this, they send a deputy back out

I get another call from the same man threatening to kill her if I do not give him 100k\$

My mother gets a call from her that she has been kidnapped, doesn't know by who and they put a black bag over her head. A man takes the phone and says he is going to kill her if we do not pay up and my mom asked who it was he said bubba and hung up

The deputy arrives, I tell him what has occurred as he is writing this down, the man calls back again and wants to know where the money is with the deputy listening to the call. He again threatens to kill her if I do not pay and hangs up.

The deputy radios this in to start tracing her phone and more deputies arrive.

The man calls back again wanting to know where the money is, I get him to give me an account number by asking how I can get the money to him. He gives me an account number, the deputy writes it down.

They traced her phone to a house in sampson county, the a motel in dunn known for drugs and prostitution

The man calls back and says he is going to kill her, starts counting down and hangs up. Deputy tells me they have officers almost to her location.

I walk inside to get a jacket because it is cold, a lot of police cars are in the driveway. I come back outside, they are all gone...

I call the sheriff's dept several times before a detective calls me back and says she is safe, she doesn't know who the man was and they left her at the motel.

Why would they leave an intoxicated woman with a man she does not know in a motel who has been making threats to kill her to her husband/boyfriend?

Did the detectives interview the man?

My friends picked her up the next morning in said motel parking lot crying and shaking that the police deemed her "safe" and brought her home later as my friend told me "let her get cleaned up and calmed down but looked like she had had a bad time"

Why was no one charged? The detective said the man (but he doesn't know who it was, so how could he know his intentions?) had no real intention to collect a ransom. The law does not care as the effect/outcome was the same (terrorize me into giving him a large sum of cash to protect the life of someone I loved)...I believed it to be real, the officers on the scene believed it, my mother believed it.

If I break into a home even without the intent to kill anyone and someone dies, even a partner in crime. I am charged with the death. Extortion, Blackmail and/or Harassment were all laws broken by the man that night...not a single charge was filed.

I am now asking that the courts request the SBI to review the handling of this case by Johnston County Sheriff's office, as well as to issue a subpoena for the release of all records from Johnston County Sheriff's Office, Dunn Police Dept including all officers names, notes and police recordings, body cam footage from case #20196544 for review for possible civil suits against unknown subjects as well as departments named. I am still having nightmares about that night and I feel that I was denied justice and I am certain something happened to her after the police left her there based on statements from mutual friends who picked her up.
