RE: Public Records Request – Oregon police data collection

Mr. Sinyangwe,

Please review this letter and the enclosed attachment in response to your public records request for Oregon police data collection.

In regards to your 1st request for the number of use of force incidents, we have enclosed our responses from 2013-2020. Please note that the verbiage on collected data has changed over the years and some responses may not be identical. Additionally, we have enclosed the material responsive to your second request for the total number of civilian complaints alleging misconduct from 2013-2020.

In response to requests 3, 4, and 5 for civilian complaints from 2013-2020 (alleging excessive force, racial profiling, or criminal conduct) the department did not locate any complaints that fit within the scope of your request.

In regards to your request for all information reported to the FBI's national Use-of-Force data collection program, we have enclosed screenshots indicating what has been uploaded. The Woodburn Police Department has continually reported a "zero" report.


In response to your 7th request for a list of all officer-involved shootings that were directed at a person from 2013-2020, the Woodburn Police Department has no responsive documents. The Woodburn Police Department did not have any Officer-involved shootings during this time frame.

In response to the first two sentences of Request #8 regarding lawsuits and financial settlements, the City only can respond to records that the City keeps as custodian of those records. Accordingly, to the degree that Request #8 requests records and, assuming that any such records exist, the City is not the legal custodian of these records. The City of Woodburn is not self-insured but is instead insured by the City-County Insurance Trust. If any records relevant to

Request #8 exist, the request should be directed to the City-County Insurance Trust. In response to sentences three and four of Request #8, the Woodburn Police Department does not submit any documents to state/local/federal agencies listing the lawsuits brought against the police department.
