Any and all available logs of public records requests submitted to this office during the period from January 1, 2014 through July 15, 2019. Please include all available segregable information, including the name or organization making the request, the descriptions of requested documents, the date on which the request was made, the final status of the request, and any other applicable data.

Please be advise that the County, its officials, and departments do not produce documents or records that are protected by the attorney-client privilege or the attorney work product doctrine under Georgia or federal law, or that are otherwise exempt from production under the Georgia Open Records Act. The County expressly reserves and does not waive any statutory exemptions from disclosure provided by O.C.G.A. §50-18-72, et seq. and other applicable laws. When records are properly requested and subject to disclosure under the Open Records Act, the County charges an administrative fee for search and retrieval commensurate with the terms of the Act, in addition to charges for photocopying. The administrative fee is the hourly rate of the lowest-paid employee who is qualified to fulfill the request—no charge for the first 15 minutes of time spent. Copying fees are as follows: 8 ½ x 11 (letter) and 8 ½ x 14 (legal) documents, \$.10 per page; 11 x 17 (ledger) documents, \$1 per page; 24 x 36 documents/plots/maps, \$5 per page; CDs \$2; DVDs \$3; USB drive \$10. **Under the Open Records Act, we have (3) business days from receipt of your request to provide a response.**
