NARRATIVE

On 02-15-19 at 1800 I responded to assist the public at the intersection of RTE 93 and RTE 31. Upon arrival I was met by the caller/complainant [REDACTED] who stated he has a custody problem with his ex-wife [REDACTED]. [REDACTED] produced family court paperwork effective on 2/15/19, that states he has sole custody of his two children [REDACTED] and [REDACTED]. [REDACTED] also stated that he has yet to receive custody of his children, and advised patrol that [REDACTED] has made reference to going into hiding with their children as a result of the court order.

[REDACTED] LKA was [REDACTED] and she is known to drive a 2017 Gray Honda Pilot NY# [REDACTED] which is registered to her name. I attempted to make contact at the residence but produced negative results, there were no vehicles in the driveway and the garage door windows were covered. [REDACTED] also advised patrol [REDACTED] could be staying at an address on [REDACTED] in Tonawanda. Tonawanda PD checked that residence, but produced negative results as well. I made contact with [REDACTED], who is [REDACTED] sister and also the owner of the [REDACTED] residence. She stated "she has no idea where she went" and was providing inconsistent and illogical answers to my questions, as well as being uncooperative in regards to providing her own personal information (DOB, description, etc.)

[REDACTED] was advised an alert will be created for [REDACTED] as well as the vehicle she is driving. He is to be contacted if [REDACTED] and/or the children are located. I am requesting this case to be forwarded to CIB for further investigation.
