Dear Mr. Bradley:

This is in response to your Freedom of Information (FOIA) request for a copy of the Official Military Personnel File, DD Form 214, evaluation reports, unit assignments with dates, promotions, administrative remarks, training courses, military education received, and full military awards and citations pertaining to Mr. Nils C. Sorenson. This office received your request on December 27, 2018, and processed your request under the provisions of the Freedom of Information and Privacy Acts. We assigned your request control numbers FP-19-006457 and FA-19-0746 for administrative and tracking purposes – please refer to these numbers when inquiring with us about your request.

The following determination is made by the undersigned under the authority delegated to me by the Commanding General, U.S. Army Human Resources Command. The Army Military Human Resources Record/Official Military Personnel File pertaining to Mr. Nils C. Sorenson is being withheld in its entirety after consultation with the United States Army Special Operations Command.


On behalf of the United States Special Operations Command, the requested records are being withheld pursuant to 5 U.S.C. § 552, (b)(3) (10 U.S.C. § 130b), to protect personally identifiable information regarding personnel assigned to an overseas, sensitive or routine deployable unit; (b)(3) (10 U.S.C. § 130c), to protect sensitive information of foreign governments and international sources and methods; (b)(3) (50 U.S.C. § 3024(i), to protect intelligence sources and methods; (b)(6) and (b)(7)(C), to protect personal information that, if disclosed, could be reasonably expected to or would result in a clearly unwarranted invasion of personal privacy; (b)(7)(D), to protect records or information that could reasonably be expected to disclose the identity of a confidential source; (b)(7)(F), to protect personal information that, if disclosed, could reasonably be expected to endanger the life or physical safety of an individual.

In light of the above, your request is denied. You may appeal this determination by submitting a letter in writing to this Command, ATTN: AHRC-FOI. Your appeal should contain a copy of this letter and must be postmarked or electronically transmitted within 90 calendar days of the date of this letter and outline the basis on which you disagree with our decision. Upon receipt of any appeal, I will forward your appeal to the Director of Oversight and Compliance, Office of the Secretary of Defense (OSD), 4800 Mark Center Drive, Alexandria VA 22350-1700.
