
Dear Recipient:

Thank you for contacting the National Personnel Records Center. We have been attempting to verify the veteran's military service from the information that has been provided. Pursuant to the Freedom of Information Act, I hereby request the following records: The Official Military Personnel File (OMPF) concerning Donald C Hubbard including Form DD-214, all Fitness Report and Counseling forms NAVPERS Form 1610/2, NAVPERS form 1610/1,, NAVPERS Form 1611, Administrative Remarks Navpers 1070/613, Background Summary (NAVPERS Form 1640/32), Cumulative Record of Training (NAVPERS Form 5300/16), history of assignments NAVPERS 1070/605, Navy Training History NAVPERS form 601-4, all military decoration and award citations, all military education, military service number.

Mr Donald C Hubbard claimed service in United States Navy as a commissioned officer from approximately 1979–1990 active duty. Graduated United States Naval Academy class of 1979.

Claims awarded many decorations including meritorious service medal, Navy commendation medal, navy achievement medal, Navy Unit Commendation and others. Specifically request copy of all personal commendation medal citations and unit commendation citations with redactions if necessary.

NPRC initial search claims unable to locate the OMPF file, advised to contact Navy Personnel Command for more information such as military service number or NPRC registry number. Please assist in finding the records.

I represent the general public and thus do not know the military service number. I also request that, if appropriate, fees be waived as I believe this request is in the public interest . His background military experience and qualifications are a matter of public interest. Mr Hubbard was management leader of technology investment banking for Europe with Morgan Stanley and previously managing director with Merriman Curhan Ford & Co, currently executive with Barrings Capital. The requested documents will be made available to the general public free of charge as part of the public information service at MuckRock.com, processed by a representative of the news media/press . The requested documents will be made available to the general public, and this request is not being made for commercial purposes.

In the event that there are fees, I would be grateful if you would inform me of the total charges in advance of fulfilling my request. I would prefer the request filled electronically, by e-mail attachment if available or CD-ROM if not.
