Pursuant to the Freedom of Information Act, I hereby request the following records:

(1) An interpretation of the Manual on Uniform Traffic Control Devices for Streets and Highways ("MUTCD") issued by the Federal Highway Administration of the U.S. Department of Transportation ("FHWA") to the Missouri Department of Transportation ("MoDOT") regarding the proper choice of exit numbers. This interpretation is referenced in MUTCD Request 2(09)-149, a change request submitted by the National Committee on Uniform Traffic Control Devices ("NCUTCD"), available at <https://ncutcd.org/wp-content/uploads/meetings/2019A/AttachNo10.18B-GMI-01-ExitNumbering-Approved.pdf>, on lines 37 through 38.

(2) The request (or requests) for interpretation submitted by MoDOT to FHWA regarding the proper choice of exit numbers, along with all supporting documentation accompanying the request (or requests) for interpretation, corresponding to the above FHWA interpretation of the MUTCD.
