POST-ARREST COMPLAINT Charge 1: OPER MOTOR VEHICLE U/INFLU ALCOHOL < 21 YOA .02-.07								
On 20 March 2021, at approximately 0415, I was dispatched to a suspicious vehicle on Farm Road. While enroute, at approximately 0423, caller advised it appeared someone was out of the vehicle and there were ditches in the roadway. On arrival at the scene, I made contact, on the passenger side of the vehicle, with Dylan Soto and Zoe Boatwright. On initial contact, Ms. Boatwright was in the driver's seat, and Mr. Soto was in the passenger's seat, while the vehicle was still running. Ms. Boatwright advised Mr. Soto was driving and when he attempted to turn around their vehicle got stuck. Ms. Boatwright stated they had tried placing floor mats and a skateboard under the front tires and could not get out. I asked the subjects if they had been drinking and both stated they had not. Mr. Soto's eyes appeared glazed and red while speaking with Ms. Boatwright, and he did not speak very much. I then retrieved my PBT from my vehicle and stated I was going to take a breath test. Ms. Boatwright at this time stated she had a few drinks earlier before they left Cadillac in Martin, TN. Mr. Soto was tested first and during the test stated he had also had a few but wasn't feeling any effects. PBT showed Mr. Soto at .048 BAC and Ms. Boatwright at .040 BAC. I then asked both to get out of the vehicle. While speaking with both subjects they stated again Mr. Soto drove to Farm Road and got stuck around 0345. They then began attempting to get the vehicle out. Subjects then stated Ms. Boatwright got into the driver's seat due to Mr. Soto being able to push harder. Ms. Boatwright admitted to driving the vehicle in an attempt to get the vehicle unstuck. While speaking with the subjects out of the vehicle, I observed Ms. Boatwright's eyes also appeared glassy and red. Both subjects were then placed under arrest. While securing the keys in the driver's seat the smell of alcoholic beverage was present in the
