Good Afternoon Mr. Prince:

Thank you for your email. KRS 61.168(2) permits disclosure of body-worn camera video upon request unless it meets a certain requirement within the statute.

Additionally, not all parts of the video are exempt from disclosure, even though one part may be.

Pursuant to KRS 61.878(4), the FST video may need to be redacted, but that does not automatically exempt the other parts of the video (booking, transport, etc).
