Pursuant to the Freedom of Information Act, I hereby request the following records:

1. All communications and message traffic to or from the Office of Defense Attaché in Israel from June 5, 1967 to June 10, 1967.
2. All communications and message traffic to or from the Office of Defense Attaché in Israel from June 5, 1967 to June 10, 1967, including, but not limited to, messages received from or sent to the Army Communications Station/Center at the Pentagon.
3. All communications and message traffic to or from the Office of Defense Attaché in Israel from June 5, 1967 to June 10, 1967, including, but not limited to, messages relayed via the Army Communications Station/Center at the Pentagon.

The requested records will be made available to the general public and this request is not being made for commercial purposes. I am an independent researcher and journalist. My previous work on the USS Liberty led to the adoption of a resolution, which I authored, at the American Legion's 2017 national convention. That resolution is published on pages 124-5 of US House of Representatives Document 115-91 and my work was featured in the August 30, 2017, print and online edition of Seattle Weekly.

In the event that there are fees, I would be grateful if you would inform me of the total charges in advance of fulfilling my request. I would prefer the request filled electronically, by e-mail attachment if available or CD-ROM if not.
