#### Dear Ms. Agoranos:

The Public Access Bureau has received the attached Request for Review of the response by the Village of Mount Prospect (Village) to a Freedom of Information Act (FOIA) request submitted by Mr. David Sutherland, Organizer, Northwest Side Coalition Against Racism & Hate. We have determined that further action is warranted.

On February 5, 2021, Mr. Sutherland submitted a FOIA request to the Village seeking copies of:

Any and all written records (including but not limited to hard-copy documents, memos, emails, word processor documents, PDF documents, PowerPoint Files, etc.) between January 1, 2021 and the date this request is processed (inclusive of those dates) which contain one or more of the following words, terms, or phrases (case-insensitive):

- "blue lives matter"
- "blue lives"
- "thin blue line"
- "police lives matter"
- "all lives matter"

- "black lives matter"
- "BLM"
- "TBL"<sup>[1]</sup>

On that same date, the Village responded that it believed it had already answered the request. Later on that same date, Mr. Sutherland replied that although the request was similar to one submitted on October 22, 2020, the timeframe of records created since January 1, 2021, is different. Mr. Sutherland stated: "Community members have submitted multiple communications regarding the thin blue line to the village. During the village board meeting [citation], the Mayor mentioned receiving comments from two dozen officers with a majority of officers writing in favor of the symbol. Those documents will pertain to this request."<sup>2</sup> On February 17, 2021, Mr. Sutherland e-mailed the Village noting that he was still waiting on a response to his request and specifying that his request included both the police officers' survey responses and e-mails to and from the Village regarding the thin blue line patch. On February 19, 2021, the Village denied the police officers' survey responses pursuant to section 7(1)(f) of FOIA (5 ILCS 140/7(1)(f) (West 2018), as amended by Public Acts 101-434, effective January 1, 2020; 101-452, effective January 1, 2020; 101-455, effective August 23, 2019), and stated that it would follow up regarding the e-mails. On February 26, 2021, the Village provided Mr. Sutherland with copies of certain responsive e-mails, but redacted information pursuant to section 7(1)(b) of FOIA (5 ILCS 140/7(1)(b) (West 2018), as amended by Public Acts 101-434, effective January 1, 2020; 101-452, effective January 1, 2020; 101-455, effective August 23, 2019).

On March 1, 2021, Mr. Sutherland submitted the above-referenced Request for Review contesting several aspects of the Village's handling of his request. He alleges: (1) the Village improperly withheld police officers' survey responses because the Village's mayor publicly cited and identified those records during an open meeting on February 2, 2021; (2) the Village's response to his request was late; (3) the Village's production of e-mails is incomplete based on a comparison with the submissions the mayor read aloud during the February 2, 2021, meeting; and (4) the Village's redactions are seemingly random and unexplained.

As required under section 9.5(c) of FOIA (5 ILCS 140/9.5(c) (West 2018)), please provide unredacted copies of all of the responsive records for this office's confidential review. Additionally, please provide a detailed written answer to Mr. Sutherland's allegations, addressing: (1) the legal and factual bases for the applicability of the section 7(1)(f) exemption, addressing whether the mayor publicly cited and identified the police officers' survey responses; (2) whether the Village's response to the request was timely; (3) how the Village construed and searched for records responsive to the request, explaining the recordkeeping system(s) searched,

how they were searched, and who was consulted; and (4) what information the Village redacted from the e-mails it provided to Mr. Sutherland and why.

This information must be submitted to this office within seven (7) business days after receipt of this letter. Under FOIA, "[t]he Public Access Counselor shall forward a copy of the answer to the person submitting the request for review, with any alleged confidential information to which the request pertains redacted from the copy. The requester may, but is not required to, respond in writing[.]" 5 ILCS 140/9.5(d) (West 2018). If you claim that any portion of your written response is confidential, please send two versions of your response letter: a complete copy for this office's confidential review and a redacted version suitable for this office to forward to the requester.

Hello Josua,

After our conversation on Friday I promised to give you a headsup when Mount Prospect finally provided resulting records to our request. They did so the same day and after reviewing the records we found more anomalies we hope you can review. You can find the complete timeline and resulting records on Muckrock\* as well as in the attached .zip file.

1) Our original request for review by your office was spurred by this communication:

"The Village is denying the request for the above referenced documents pursuant to FOIA 5 ILCS 140/7 (f):

"Preliminary drafts, notes, recommendations, memoranda and other records in which opinions are expressed, or policies or actions are formulated, except that a specific record or relevant portion of a record shall not be exempt when the record is publicly cited and identified by the head of the public body. The exemption provided in this paragraph (f) extends to all those records of officers and agencies of the General Assembly that pertain to the preparation of legislative documents"

Please note this denial is currently under PAC review."

We believe the communications with the police department regarding this issue that were cited by the Mayor in a public meeting should be available to the public as described in FOIA 5 ILCS 140/1.

"Such access is necessary to enable the people to fulfill their duties of discussing public issues fully and freely, making informed political judgments and monitoring government to ensure that it is being conducted in the public interest. "

Now that they have provided final documents we also would like to note:

- 2) They did not fulfill their obligation to fulfill this request in a prompt manner as described in FOIA 5 ILCS 140/3 (d) as "5 business days". They promised records by 5 days after February 8th and then February 22nd. We didn't receive records until the 26th after I called to inquire. We are sensitive to the strain our current crisis imposes but no communication was sent to come to a mutual understanding regarding the missed deadlines.
- 3) The resulting records are incomplete. Some records are completely missing from this request. We know this to be true through review by members of the community and comparing the records publicly read aloud by the Mayor which are not included in the PDF. Examples from one Village Board meeting alone (on 02-02-2021 < https://play.champds.com/mtprospectil/event/48 > ) include:
  - A communication from Kenneth Brey read aloud by the Mayor is incomplete in the resulting record. [\*timestamp
  - A communication from Joey Carbone read aloud by the Mayor is missing in the resulting record. [\*timestamp 0:23:40]

- A communication from Rev. Clyde Brooks read aloud by the Mayor is missing in the resulting record. [\*timestamp 0:26:161
- A communication from Gweynne Ryan read aloud by the Mayor is missing in the resulting record. [\*timestamp 0:28:501
- A communication from Cathy Dunnington read aloud by the Mayor is missing in the resulting record. [\*timestamp 0:31:47]

This leads us to believe there are many more missing.

4) Whiteout redaction was confusing and seemingly random with no explanation as to why some things were redacted.

We seek to understand what law enforcement officers were attending the 1/6/2021 coup on the Capitol. All local PDs were transparent with their resulting records except for Morton Grove who blacked out ALL of the spreadsheets in entirety citing Section 7(1)(v) which states:

Vulnerability assessments, security measures, and response policies or plans that are designed to identify, prevent, or respond to potential attacks upon a community's population or systems, facilities, or installations, the destruction or contamination of which would constitute a clear and present danger to the health or safety of the community, but only to the extent that disclosure could reasonably be expected to jeopardize the effectiveness of the measures or the safety of the personnel who implement them or the public. Information exempt under this item may include such things as details pertaining to the mobilization or deployment of personnel or equipment, to the operation of communication systems or protocols, or to tactical operations.

We deserve to know if any of our local law enforcement officers could possibly be involved with this attack on our country and therefore be a threat to our communities

The residents of the Village of Mount Prospect have been embroiled in a bitter batter against a symbols of white supremacy for years. The local police department has doubled down on using this against the wishes of the most vulnerable escalating tensions in the community. A previous FOIA regarding "thin blue line" resulted in ZERO documents. That was hard enough to believe but a new request regarding a renewed complaint against the thin blue line patch has garnered a denial citing Section 7(f):

"Preliminary drafts, notes, recommendations, memoranda and other records in which opinions are expressed, or policies or actions are formulated, except that a specific record or relevant portion of a record shall not be exempt when the record is publicly cited and identified by the head of the public body. The exemption provided in this paragraph (f) extends to all those records of officers and agencies of the General Assembly that pertain to the preparation of legislative documents"

Note, the documents we are requesting were publicly cited by Mayor Arlene Juracek during the village board meeting on 02-02-2021 timestamp: 1:49:03 <a href="https://play.champds.com/mtprospectil/event/48">https://play.champds.com/mtprospectil/event/48</a>

They did mention these were under PAC review but we wanted to be included with this review process.
