Re: Your Public Records Request

Dear Mr. Vickery:

I write in response to your public records request made pursuant to the Massachusetts public records law, G.L. c. 66, § 10, and received on March 9, 2020.¹ In a March 6 letter sent via e-mail to the Records Access Officer mailbox,² you requested copies of records from the Office of the Attorney General, specifically as follows:

All records relating to:

All actions commenced between January 1, 2018 and December 31, 2019, brought pursuant to G.L. [c.] 94C, §47, in which the Commonwealth sought forfeiture of property, including:

- The case names and docket numbers;
- The courts in which the proceedings took place or are taking place;
- A description of each and every item of property whose forfeiture the Commonwealth sought;
- The names of the property owners; and
- The outcome.



Please be advised that we are still in the process of searching for, identifying, and reviewing records that may be responsive to your request and subject to disclosure under the public records law, G.L. c. 66, § 10 and G.L. c. 4, § 7, cl. 26.

Because of the time necessary to complete this process, we expect to provide you with a further response on or before March 30, 2020, i.e., within fifteen (15) business days following the initial receipt of the request. See G.L. c. 66, § 10(b)(vi). However, we will let you know if additional time is necessary. We note that there may be a charge associated with providing you with responsive records.

You have the right to appeal this response to the Supervisor of Records pursuant to G.L. c. 66, § 10A(a), and to seek judicial review of an unfavorable decision by commencing a civil action in the superior court under G.L. c. 66, § 10A(c).
