Subject: FOIA - Sunshine Law request - Code Enforcement

Please respond as soon as possible. I was taken aback when we had landscaping and concrete repair scheduled for 9/14. Three 80 pound bags were delivered to our driveway the night before and a truck with bags of rock for landscaping in the back yard was parked at the gate to our back yard an hour prior to arrival of the contractor at 2:00. The job was complete and the materials were gone by 6:00.

We are undergoing continuing improvements on the property. Is it necessary to alert the town when materials are delivered and when they will be used/installed? Many neighbors have advised a warning is the norm in this situation.

It would seem in the best interests of all involved to encourage improvements of properties in Palm Coast, not harass those trying to improve their properties with extreme and not well thought out draconian code enforcement. The entire exterior of our home has been painted and a new roof installed in the last 2 years. Recently, we trimmed many of the out-of-control shrubs in the front of the home. Please let people make improvements to their properties. It benefits all involved, including the city government.
