EMERGENCY MOTION FOR INJUNCTION PENDING DISPOSITION OF WRITS

NOW COMES, Petitioner Scott Huminski ("Huminski") and moves for an injunction while this matter is pending enjoining the State of Florida's continued harassing collection activities concerning the debt that arose at final judgment/conviction in <u>State v. Huminski</u>, 17-MM-815, Lee County Court.

Most costs and fees levied upon Huminski at trial are statutorily defined and only concern violation of statutory misdemeanors or felonies such as "crime stoppers". Huminski was not prosecuted under any Florida Statute defining a crime. Huminski was prosecuted under F.S. 900.04 which does not define a crime or cause of action. F.S. 900.04 is solely related to *sui generis* common law contempt. The State's collection activities constitute attempts at unjust enrichment of a party without standing on a *void ab initio* judgment.

Attached hereto as Exhibit "A" is a true and correct copy of the judgement entered at "misdemeanor conviction" on 3/16/2018 that does not list a crime for which Huminski was found guilty. Attached hereto as Exhibit "B" is a true and correct copy of the commitment form issued at conviction on 3/16/2018 containing monetary and sentencing information.

In support of this motion, Huminski incorporates with the same force and effect as if more fully set forth herein; his Petition and four (4) motions to take judicial notice filed in this matter which document the lack of any and all jurisdiction of the trial court in <u>State v. Huminski</u> and no plaintiff standing.

WHEREFORE, the State of Florida and it's agents, employees or assignees should be enjoined from collection activities related to the judgment debt in <u>State v.</u> <u>Huminski</u> which is hopelessly *void ab initio* for want of jurisdiction.
