I wanted to point out very plainly that anytime you tender correspondence to my offices be it to my email account or directly to the Muckrock.com website the correspondence is almost instantly shared with an estimated 5000+ major news networks and investigative journalists including CNN Digital, ProPublica, Vancouver Sun, WBTV News, Law&Crime, The Lawfare Institute, KMTV Omaha, NBC DFW, The Fresno Bee, and the Washington Post, among many others globally via www.documentcloud.org .

In addition, activists and requesters have the authority to publish and distribute your responses to members of the Senate Judiciary as well as the Senate Intelligence Committee or the United Nations General Assembly or your OIG offices for that matter.

A FOIA requester can be injured in 18 U.S.C. 2261a for the bare necessity of needing to communicate in relation to matters of fact discussed 'inter alia'. It can be considered a famine of the mind and a lack of candor under oath.

WASHINGTON — Saudi Arabia has told the Obama administration and members of Congress that it will sell off hundreds of billions of dollars' worth of American assets held by the kingdom if Congress passes a bill that would allow the Saudi government to be held responsible in American courts for any role in the Sept. 11, 2001, attacks.

It would appear your agency has intentionally took it upon themselves to engage in infamous, disgraceful conduct with intent to publish a falsehood about matters related to diplomatic security duties and records in existence which would fall within your agencies indices related to matters of historical significance.

The language of the request 20220564 was clearly spaced to require a production of both sentences as shown below and did not specify a range to search for records of the Prime Minister only a date range for a threat index. This FOIA was done in a polling fashion and FOIA Analysts of other agencies have not made the same error and if required, requested clarification.

Quoting the original request:

I was seeking any records in your custody in relation to potential threats of assassination to the Former Japanese Prime Minister Shinzo Abe for the dates: 01/01/2022 to the current date.

I was also seeking ***any records in your custody*** related to the Former Prime Minister based on the announcement of his untimely murder.

In the interest of intellectual discourse and brevity I refuse to further highlight the additional laws cited for appeal as this information is 'inter-alia'.
